AN ORDINANCE OF THE CITY COUNCIL OF THE  
CITY OF LONG BEACH AMENDING THE LONG BEACH  
MUNICIPAL CODE BY AMENDING SUBSECTIONS 39B,  
39C, 50B, 54A, 54B, 58A AND 70A OF SECTION 10.12.010  
ALL RELATING TO SPEED LIMITS ON CITY STREETS

The City Council of the City of Long Beach ordains as follows:

Section 1. Section 10.12.010 of the Long Beach Municipal Code is amended by amending Subsection 39b to read as follows:

b. Seventh Street to Fourth Street, twenty-five (25) miles per hour,

Section 2. Section 10.12.010 of the Long Beach Municipal Code is amended by amending Subsection 39c to read as follows:

c. Fourth Street to Livingston Drive, twenty-five (25) miles per hour;

Section 3. Section 10.12.010 of the Long Beach Municipal Code is amended by amending Subsection 50b to read as follows:

b. Atlantic Place to Orange Avenue, twenty-five (25) miles per hour;

Section 4. Section 10.12.010 of the Long Beach Municipal Code is amended by amending Subsection 54a to read as follows:

a. Redondo Avenue to Clark Avenue, thirty (30) miles per hour,

2 amended by amending Subsection 54b to read as follows:

3                   b.    Clark Avenue to Marwick Avenue, thirty-five (35) miles per

7 amended by amending Subsection 58a to read as follows:

8                   a.    Sixty-Eighth Street to Harding Street, twenty-five (25) miles

11                   Section 7.    Section 10.12.010 of the Long Beach Municipal Code is  
12 amended by amending Subsection 70a to read as follows:

13                   a.    Lakewood Boulevard to seven hundred fifty feet (750') west of  
14                   Lakewood Boulevard, twenty-five (25) miles per hour;

16                   Section 8.    The City Clerk shall certify to the passage of this ordinance by  
17 the City Council and cause it to be posted in three (3) conspicuous places in the City of  
18 Long Beach, and it shall take effect on the thirty-first (31st) day after it is approved by the  
19 Mayor.
