

1 FIRST AMENDMENT TO MEMORANDUM OF AGREEMENT NO. 34423

3 THIS FIRST AMENDMENT TO MEMORANDUM OF AGREEMENT NO.
4 34423 is made and entered, in duplicate, as of November 30, 2016, for reference purposes
5 only, pursuant to a minute order adopted by the City Council of the City of Long Beach at
6 its meeting on November 3, 2015, by and between LONG BEACH UNIFIED SCHOOL
7 DISTRICT ("LBUSD"), and the CITY OF LONG BEACH, a municipal corporation ("City").

8 WHEREAS, City is the fiscal agent and legal grantee for the federally-funded
9 continuation support for the National Forum on Youth Violence Prevention ("Forum") grant
10 program; and

11 WHEREAS, the Long Beach City Prosecutor is the prosecuting agency
12 authorized under State law and City Charter to file and pursue criminal prosecution for all
13 misdemeanor violations of state and local law arising within the City of Long Beach,
14 California; and

15 WHEREAS, LBUSD maintains access to all public schools in Long Beach
16 and provides resources on school campuses for youth and their parents, including the All
17 In Campaign to address truancy; and

18 WHEREAS, City and LBUSD entered into Memorandum of Agreement No.
19 34423 (the "MOA") for the purpose of addressing chronic truancy in Long Beach, along
20 with associated risk factors and negative outcomes; and

21 WHEREAS, as City received additional funding to continue the work, City
22 and LBUSD wish to extend the MOA;

23 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
24 conditions herein contained, the parties agree as follows:

25 1. The term of the MOA as specified in Sections 5 and 6 is hereby
26 extended for an additional period of one (1) year ending on September 30, 2017.

27 2. Section 5 is hereby amended to reflect that the City Prosecutor's
28 Office shall receive an additional \$15,000 to its cost reimbursement budget:

1 "Services will be reimbursed to the City Prosecutor's Office for project-related
2 expenses and will not exceed \$40,000 before September 30, 2017."

3 3. Section 5 is hereby amended to reflect that LBUSD shall receive an
4 additional \$133,000 to its cost reimbursement budget:

5 "Services will be reimbursed to LBUSD for project-related expenses and will
6 not exceed \$233,000 before September 30, 2017."

7 4. Except as expressly modified herein, all of the terms and conditions
8 contained in Memorandum of Agreement No. 34423 are ratified and confirmed and shall
9 remain in full force and effect.

10 IN WITNESS WHEREOF, the parties have caused this document to be duly
11 executed with all formalities required by law as of the date first stated above.
