WHEREAS, the parties entered Agreement No. 33069 and City granted Licensee a non-exclusive revocable license to use the Marina Parking Area for the sole purpose of conducting an arts and crafts market for the sale of arts and crafts items, and

WHEREAS, the parties entered into the First Amendment to Agreement No. 33069 on January 21, 2014 to extend the term of the Agreement for one (1) year; and

WHEREAS, the parties desire to exercise the second option to extend the term of this Agreement for an additional one (1) year term:

NOW, THEREFORE, in consideration of the mutual terms and conditions in Agreement No. 33069 and herein, the parties agree as follows:

- 1. Section 3 of Agreement No. 33069 is amended in its entirety to read as follows:
- Term, Termination and Extension. "3. The term of this Second Amendment to Agreement No. 33069 shall commence on February 1, 2015, and shall terminate on January 31, 2016, unless sooner terminated as provided in this Agreement, or unless the services to be performed hereunder or the Project is completed sooner. The term may be extended for up to two (2) separate, consecutive periods of one (1) year each at the sole discretion of the City Manager and subject to approval by the Coastal Commission. Either party may terminate this License by giving at least thirty (30) days prior notice to the other party as described below."
