## SECOND AMENDMENT TO CONTRACT NO. 34212

THIS SECOND AMENDMENT TO CONTRACT NO. 34212 is made and entered, in duplicate, as of December 13, 2018, for reference purposes only, pursuant to Resolution No. RES-16-0005, adopted by the City Council of the City of Long Beach at its meeting on January 19, 2016, by and between SOUTHERN CALIFORNIA FLEET SERVICES, INC., a California corporation ("Contractor"), with a place of business at 2855 Sampson Avenue, Corona, California 92879, and the CITY OF LONG BEACH ("City"), a municipal corporation.

WHEREAS, the Fleet Services Bureau performs preventative maintenance and repairs to 31 active Seagrave fire truck units as part of the City's fleet maintenance program; and

WHEREAS, City and Contractor (the "Parties") entered into Contract No. 34212 whereby Contractor agreed to provide these services; and

WHEREAS, the Parties desire to extend the term an additional one (1) year period;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

- 1. Section 3 of Contract No. 34212 is hereby amended to read as follows:
- "3. The term of this Contract shall be deemed to have commenced on February 1, 2016, and shall terminate at midnight on January 31, 2020, unless sooner terminated as provided in this Contract."
- Except as expressly modified herein, all of the terms and conditions contained in Contract No. 34212 are ratified and confirmed and shall remain in full force and effect.
