

SIXTH AMENDMENT TO AGREEMENT NO. 34491
34491

THIS SIXTH AMENDMENT TO AGREEMENT NO. 34491 is made and entered, in duplicate, as of January 6, 2022, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on November 16, 2021, by and between ABM AVIATION, INC. formerly known as ABM PARKING SERVICES, INC., a Georgia corporation, with a place of business at 1150 South Olive Street, Los Angeles, California 90015 ("Operator"), and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City and Operator (the "Parties") entered into Agreement No. 34491 (the "Agreement") whereby Operator agreed to perform services in connection with airport parking operations and management at the Long Beach Airport; and

WHEREAS, the Parties entered into a First Amendment to the Agreement to add \$263,531 to the first year of the Agreement; and

WHEREAS, the Parties entered into a Second Amendment to the Agreement to reflect the name change and add \$269,354 to the second year of the Agreement; and

WHEREAS, the Parties entered into a Third Amendment to the Agreement to add \$1,400,640 to the third year of the Agreement; and

19 WHEREAS, the Parties entered into a Fourth Amendment to the Agreement
20 to add \$1,446,862 to the fourth year of the Agreement and extend the term to November
21 30, 2020; and

22 WHEREAS, the Parties entered into a Fifth Amendment to the Agreement to
23 add \$1,493,161 to the fifth year of the Agreement and extend the term to November 30,
24 2021; and

25 WHEREAS, the Parties desire to add \$1,657,207 to the sixth year of the
26 Agreement and extend the term one (1) additional one-year period;

27 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
28 conditions herein contained, the Parties agree as follows:

1 1. The Agreement amount shall be increased by One Million Six Hundred
2 Fifty-Seven Thousand Two Hundred Seven Dollars (\$1,657,207) for a total not to exceed
3 Agreement amount of Eight Million Six Hundred Sixty-Two Thousand Three Hundred
4 Ninety-One Dollars (\$8,662,391).

5 2. Section 2 of the Agreement is hereby amended to read as follows:

6 “2. TERM. The term of this Agreement shall commence at midnight on
7 December 1, 2016, and shall terminate at 11:59 p.m. on November 30, 2022, unless
8 sooner terminated as provided in this Agreement.”

9 3. Except as expressly amended in this Amendment, all terms and
10 conditions in Agreement No. 33491 are ratified and confirmed and shall remain in full force
11 and effect.
