## **PROGRESS UPDATES, ACCOMPLISHMENTS & NEXT STEPS FROM SUSTAINABLE CITY STAFF**

Meredith Reynolds, Sustainability Coordinator made the following announcements:

The retreat for the Sustainable City Commission will be held at Rancho Los Cerritos at the same time of the regular meeting - 4:00 p.m. Thursday June 24, 2010. The purpose of the retreat is to draft a workplan and have conversations about specific actions and programs that the Commission would like to support and take before City Council for approval.

Rain barrel installations are continuing and have been very successful. New interns will be introduced at the retreat : Charlene, Planning Student at UC Irvine; Mike, Planning & Design Student at USC; Joy, Reed College in Portland, Oregon; and Christine, Film Student who will be producing a documentary on the projects being done by the Sustainable City Staff.

The Sustainable City Staff applied for a grant in partnership with the Workforce Development Team. The \$2.4 million grant is for the Low Impact Development Academy to continue the work of beautification and tree planting.

Work was done with the new City Farm and Garden on 15th Street.

The Sustainable Staff is working on the greenhouse gas inventory for 2009 and the results will be documented at the beginning of the next calendar year. This year the greenhouse gases have been reduced.

The Solar Trash Compacting Garbage Can Pilot Project is moving forward and will run for six months. The recycle bins will be placed in various local business districts - Bixby Knolls at Carson & Atlantic; Downtown at Pine & Broadway; and Belmont Shore at 2nd & Argonne. The trash is put into the bin and the solar panel on top operates the battery to compact the trash and at the end of the day a cube of trash is produced. If the pilot is successful, the bins will be placed in larger areas such as the Long Beach Convention Center.

## **ANNOUNCEMENTS & COMMENTS FROM SUSTAINABLE CITY COMMISSIONERS**

Chair Wibroe spoke.

Commissioner Greenwood shared good news from a LEED Consultant at Turner Construction who complimented the City of Long Beach on its excellent green building programs. There were about 35 companies represented in the class focusing on construction project management.

Vice Chair Kajer announced that May has been declared the official Breakwater awareness month for the City of Long Beach which is in association with an event sponsored by 4th District City Councilmember Patrick O'Donnell. The Councilmember invited the Army Corp of Engineers to a meeting to discuss the status of the feasibility study to reconfigure the Long Beach Breakwater which is now called the East San Pedro Bay Improvement Project. The Army Corp of Engineers has determined that there is federal interest in moving the project forward. The estimated cost of the study is \$8 million and the City of Long Beach, as the local sponsoring agency, would be responsible to provide approximately \$4 million which would be phased out over the length of the project estimated to last about four years. City Council will be considering this item some time in mid June 2010.

Vice Chair Kajer also announced the 2nd & PCH EIR is now public and open for comment until June 4, 2010. The community has considerable concerns about the effect of the project on the community and whether or not this is the correct project for the location at 2nd & PCH. The EIR is posted on the Planning Department website so please send comments by June 4, 2010.

Commissioner Thorne pointed out the names for Chair and Vice Chair have not been updated and Commissioner Kincaid's name should be removed due to his resignation on April 22, 2010.

Theclinjoris Roberts, Clerk, spoke.

Commissioner Greenwood announced the results of the Friends of the LA River Wrigley Area Neighborhood Alliance joint event, held on May 8, 2010, cleaning up the estuary as well as picking up trash in the neighborhoods. Within three hours approximately four tons of trash was picked up between the river and the neighborhood streets and alleys. A survey was done of the trash bags and weighing them out it was noted that at Willow Street there was a lot of metal compared to the other sites. It was difficult for the volunteers to get the metal out of the riverbed because of the difficulty at the site so about eight piles of metal was left behind in the estuary. More and more metal is being left in the riverbed so at some point Commissioner Greenwood would be interested to find out why so much metal is being left on the riverbed.
