FIRST AMENDMENT TO AGREEMENT NO. 31305

THIS FIRST AMENDMENT is made and entered, in duplicate, as of February 10, 2011, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on February 1, 2011, by and between COMPULINK MANAGEMENT CENTER, INC. DBA LASERFICHE SOLUTIONS GROUP, a California corporation ("Contractor"), with a place of business located at 3545 Long Beach Boulevard, #110, Long Beach, California 90807, and the CITY OF LONG BEACH ("City"), a municipal corporation.

WHEREAS, the City desires to purchase Electronic Document Management Solution software and services; and

WHEREAS, the Parties executed Agreement No. 31305 wherein Contractor agreed to provide City with Electronic Document Management Solution software; and

WHEREAS, the Parties now desire to amend the amount of the Agreement;

NOW, THEREFORE, in consideration of the terms and conditions

contained in this Agreement, the parties agree as follows:

- 1. Section 1 of Agreement No. 31305 is hereby deleted in its entirety and amended as follows:
- "1. The Santa Monica Agreement with Contractor is incorporated by this reference as if fully set forth, and the same terms and conditions contained in the Santa Monica Agreement shall be applicable here except as follows:
 - A. Wherever the Santa Monica Agreement refers to the City of Santa Monica, it shall be deemed to refer to the City of Long Beach;
 - B. Contractor shall sell, furnish and deliver to the City Electronic Document Management Solution software and services of substantially the same type and kind purchased by the City of Santa Monica and on the same terms and conditions offered to the City of Santa Monica, except as modified by Exhibit "A" attached to and incorporated in this Agreement, for an amount not to exceed

Three Hundred Sixty-Four Thousand Dollars (\$364,000.00), including tax, which will be paid over a five (5) year period, with a One Hundred Thousand Dollar (\$100,000.00) contingency if necessary, and if funds are available for implementation services. Additionally, beginning in year 2011, a Two Hundred Thousand Dollar (\$200,000.00) annual contingency is added through 2014 if necessary, and if funds are available for implementation services, for a period extending until the warranty on the Electronic Document Management Solution software expires. To the extent that the Santa Monica Agreement and this Agreement are inconsistent, the following priority shall govern: (1) this Agreement and (2) the Santa Monica Agreement.

- C. Payment for the Electronic Document Management Solution purchased from Contractor by the City shall be made by the City on delivery to and acceptance of the Electronic Document Management Solution by the City and submittal of an invoice to the City. Payment is due thirty (30) days after the date of the invoice.
 - D. All warranties shall accrue to the City of Long Beach.
- E. The parties may, by mutual agreement, amend this Agreement with the approval of the City's City Council."
