





I want to thank you in advance for taking the time to read my letter. My name is Jon Sloan and I have lived on 48<sup>th</sup> street for about five years now. My wife has been here longer, I would guess for about 30 plus years, as she grew up here. Since I started courting my wife in 1991, I have seen many changes happen to this neighborhood and much of it not so good. 
