AN ORDINANCE OF THE CITY COUNCIL OF THE
CITY OF LONG BEACH AMENDING THE LONG BEACH
MUNICIPAL CODE BY AMENDING SECTION 2.84.020,
ALL RELATING TO CONTRACTS

The City Council of the City of Long Beach ordains as follows:

Section 1. Section 2.84.020 of the Long Beach Municipal Code is
hereby amended to read as follows:

2.84.020 Nondiscrimination in City contracts and purchase orders.

All contracts and purchase orders between the City and other
persons and entities of any kind shall contain language which prohibits
discrimination in employment and discrimination with respect to
performance under the contract or purchase order on the basis of race,
color, religion, national origin, sex, sexual orientation, gender identity,
AIDS, HIV status, age, disability, or handicap, subject to federal and state
laws, rules and regulations.

Section 2. The City Clerk shall certify to the passage of this Ordinance by
the City Council and cause it to be posted in three conspicuous places in the City of Long
Beach, and it shall take effect on the thirty-first day after it is approved by the Mayor.
