1 FIRST AMENDMENT TO CONTRACT NO. 30681

3 THIS FIRST AMENDMENT TO CONTRACT NO. 30681 is made and  
4 entered, in duplicate, as of September 8, 2008 for reference purposes only, pursuant to a  
5 minute order adopted by the City Council of the City of Long Beach at its meeting held on  
6 September 18, 2007, by and between ANTHONY R. OSTOS, consultant, with offices  
7 located at 935 South Glenview Road, West Covina, California 91791 ("Organization"),  
8 and the CITY OF LONG BEACH, a municipal corporation (the "City").

9 WHEREAS, the City has received a grant from the U.S. Department of  
10 Justice ("DOJ") for a program that aims to prevent, control and reduce violent crime, drug  
11 abuse and gang activity to residents of the City in Police Beats 4 and 5 (the "Weed and  
12 Seed Program"); and

13 WHEREAS, the funds awarded for the Weed and Seed Program were not  
14 expended within the current grant period; and

15 WHEREAS, the parties entered Contract No. 30681 whereby Organization  
16 agreed to provide Weed and Seed Services to residents of the City in Police Beats 4 and  
17 5; and

18 WHEREAS, the parties desire to extend the term of the Contract to allow for  
19 the full execution of the grant and allocated funds;

20 NOW, THEREFORE, in consideration of the mutual terms and conditions  
21 herein contained, the parties agree as follows:

22 1. Section 3 of Contract No. 30681 is amended in its entirety to read as  
23 follows:

24 "Section 3. The original term of this Contract shall commence at midnight  
25 on October 1, 2007, and shall terminate at 11:59 p.m. on September 30, 2008, and the  
26 first extended term shall commence at midnight on October 1, 2008, and, unless sooner  
27 terminated as provided herein shall terminate at 11:59 p.m. on September 30, 2009."

28 2. Except as expressly modified herein, all of the terms and conditions


