

1 FIRST AMENDMENT TO AGREEMENT NO. 30762

3 THIS FIRST AMENDMENT TO AGREEMENT NO. 30762 is made and
4 entered, in duplicate, as of October 28, 2009, for reference purposes only, pursuant to a
5 minute order adopted by the City Council of the City of Long Beach at its meeting on
6 June 10, 2008, by and between ITERIS, INC., a Delaware corporation, with a place of
7 business at 1700 Carnegie Avenue, Suite 100, Santa Ana, California 92705
8 ("Consultant"), and the CITY OF LONG BEACH, a municipal corporation ("City").

9 WHEREAS, City requires specialized services requiring unique skills to be
10 performed in connection with As-Needed Transportation Engineering, Transportation
11 Planning, and Related Technical and Professional Services ("Project"); and

12 WHEREAS, City has selected Consultant in accordance with City's
13 administrative procedures and City has determined that Consultant and its employees
14 are qualified, licensed, if so required, and experienced in performing these specialized
15 services; and

16 WHEREAS, City desires to have Consultant perform these specialized
17 services, and Consultant is willing and able to do so on the terms and conditions in this
18 Agreement; and

19 WHEREAS, the parties desire to increase the amount of the Agreement by
20 \$200,000;

21 NOW, THEREFORE, in consideration of the mutual terms and conditions in
22 the Agreement and in this Amendment, the parties agree as follows:

23 1. Section 1.A. of Contract No. 30762 is amended in its entirety to read
24 as follows:

25 "1. SCOPE OF WORK OR SERVICES.

26 A. Consultant shall furnish specialized services more particularly
27 described in Exhibit "A", attached to this Agreement and incorporated by this
28 reference, in accordance with the standards of the profession, and City shall pay

for these services in the manner described below, not to exceed \$700,000, at the rates or charges shown in Exhibit "A".
