EIGHTH AMENDMENT TO AGREEMENT NO. 34674

THIS EIGHTH AMENDMENT TO AGREEMENT NO. 34674 is made and entered, in duplicate, as of July 20, 2021, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on July 13, 2021, by and between CSG CONSULTANTS, INC., a California corporation ("Consultant"), with a place of business at 3707 West Garden Grove Boulevard, Suite 100, Orange, California 92868, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City and Consultant (the "Parties") entered into Agreement No. 34674 (the "Agreement") whereby Consultant agreed to provide as-needed plan review and inspection services; and

WHEREAS, the Parties entered into a First Amendment to the Agreement to add \$120,000 for a total not to exceed amount of \$200,000; and

WHEREAS, the Parties entered into a Second Amendment to the Agreement to add \$140,000 for a total not to exceed amount of \$340,000; and

WHEREAS, the Parties entered into a Third Amendment to the Agreement to add \$30,100 for a total not to exceed amount of \$370,100; and

WHEREAS, the Parties entered into a Fourth Amendment to the Agreement to add \$6,500 for a total not to exceed amount of \$376,600; and

WHEREAS, the Parties entered into a Fifth Amendment to the Agreement to add \$73,900 for a total not to exceed amount of \$450,500 and extend the term to July 31, 2020; and

WHEREAS, the Parties entered into a Sixth Amendment to the Agreement to add \$160,500 for a total not to exceed amount of \$611,000; and

WHEREAS, the Parties entered into a Seventh Amendment to the Agreement to add \$150,000 for a total not to exceed amount of \$761,000 and extend the term to July 31, 2021; and

WHEREAS, the Parties desire to extend the term to October 31, 2021;

1 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
2 conditions herein contained, the Parties agree as follows:

3 1. Section 2 of the Agreement is hereby amended to read as follows:

4 "2. TERM. The term of this Agreement shall commence at midnight on
5 August 1, 2017, and shall terminate at 11:59 p.m. on October 31, 2021, unless sooner
6 terminated as provided in this Agreement, or unless the services or the Project is
7 completed sooner."

8 2. Except as expressly amended herein, all of the terms and conditions
9 in Agreement No. 34674 are ratified and confirmed and shall remain in full force and effect.
