FIRST AMENDMENT TO SUBCONTRACT NO. 30898

THIS FIRST AMENDMENT TO SUBCONTRACT NO. 30898 FOR VETERANS AND MENTAL HEALTH SERVICES (this "Subcontract") is made and entered, in duplicate, as of June 8, 2009 for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on August 14, 2007, by and between UNITED STATES VETERANS INITIATIVE, a California nonprofit corporation ("Organization"), with offices located at 2001 River Avenue, Long Beach, California 90810, and the CITY OF LONG BEACH, a municipal corporation (the "City").

WHEREAS, the City has received monies from the County of Los Angeles ("County") pursuant to Contract Number AO-08-060 for Homeless Veterans Initiative ("County Contract") for a program that aims to develop a comprehensive service package to improve and enhance specialized services for homeless veterans in the City; and

WHEREAS, as part of the County Contract, the City desires to enter into subcontracts with certain organizations that provide veterans and mental health services to homeless veterans in the City and Organization has been selected as a sub-recipient of monies under the County Contract; and

WHEREAS, the parties entered Subcontract No. 30898 whereby Organization agreed to provide these services to the City; and

WHEREAS, the parties desire to extend the term of this Subcontract;

NOW, THEREFORE, in consideration of the mutual terms and conditions in Subcontract No. 30898 and herein, the parties agree as follows:

1. Section 3 of Subcontract No. 30898 is amended in its entirety to read as follows:

"4. The initial term of this Subcontract shall commence at midnight on July 21, 2008 and shall terminate at 11:59 p.m. on July 20, 2009. The extended term of this Subcontract shall commence at midnight on July 21, 2009, and unless sooner


