3 THIS FIRST AMENDMENT TO AGREEMENT NO. 30705 is made and
4 entered, in duplicate, as of May 3, 2011 for reference purposes only, pursuant to a
5 minute order adopted by the City Council of the City of Long Beach at its meeting held on
6 June 10, 2008, by and between ALBERT GROVER & ASSOCIATES, INC., a California
7 corporation, with a place of business at 211 East Imperial Highway, Suite 208, Fullerton,
8 California 92635 ("Consultant"), and the CITY OF LONG BEACH, a municipal corporation
9 ("City").

10 WHEREAS, the City and Consultant entered into Agreement No. 30705
11 whereby Consultant agreed to provide As-Needed Transportation Engineering,
12 Transportation Planning, and Related Technical and Professional Services; and

13 WHEREAS, the parties desire to extend the term of the Agreement;

14 NOW, THEREFORE, in consideration of the mutual terms and conditions in
15 the Agreement and in this First Amendment, the parties agree as follows:

16 1. Section 2 of Agreement No. 30705 is hereby amended to read as
17 follows:

18 "2. TERM. The term of this Agreement shall commence at midnight on
19 June 10, 2008, and shall terminate at 11:59 p.m. on June 9, 2012, unless sooner
20 terminated as provided in this Agreement, or unless the services or the Project is
21 completed sooner."

22 2. Except as expressly amended in this First Amendment, all terms and
23 conditions in Agreement No. 30705 are ratified and confirmed and shall remain in full
24 force and effect.






