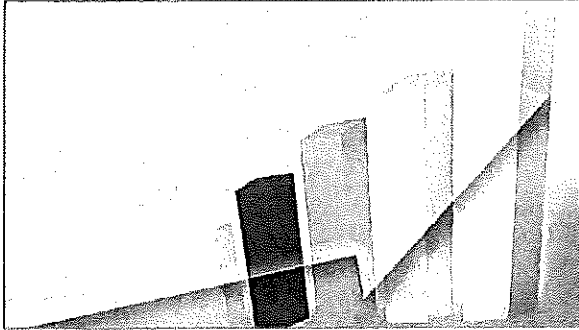

## Rates or Charges

## FEE SCHEDULE



Effective **November 1, 2017** the schedule of hourly fees below includes rates for proposed personnel. These rates include full burden costs and are expected to remain fixed through **October 31, 2018**.

All Cost Proposal submitted to the City of Long Beach during the period of November 1, 2017 through October 31, 2018 will include the hourly rates below.

All hourly rates included in Cost Proposals submitted prior to November 1, 2017 will not be affected.

### Pacifica Services, Inc.

Proposed Position	Hourly Rate
Labor Compliance Officer	\$95
Deputy Labor Compliance Officer	\$90
Business Development Manager	\$95
Sr. Labor Compliance Analyst	\$85
Labor Compliance Analyst	\$80
Senior Labor Compliance Auditor	\$90

**Note:** Hourly Rates are subject to 3.5% increase annually.

**Reimbursable Costs:** As needed and approved by City of Long Beach staff, direct expenses attributed to incidental materials and services, such as report reproductions, plan set printing, parking fees, specific software, etc., will be billed at cost plus 10% mark-up. Does not include materials provided for Contractor DBE and Prevailing Wage Compliance Training Workshops. Mileage is from Pacifica Corporate office to work site.

Mileage rate = \$0.535

**Overtime Rates:** In the event of overtime hours or worker field interviews conducted for construction work performed after 5:00 pm, the rate charged will be 1.5 times the Hourly Rate specified above.
