

ficers believe the discipline system favors those with connections. But he praised the report, saying that it did a good job of analyzing claims of bias based on gender, rank and ethnicity. He said it would have been impossible to quantify all the complaints of disparities in punishments.

"You've got a perception that if you're a friend of the chief's, then all of the sudden it's better," Soboroff said. "You can't quantify that. How do you do the statistics on that? So that's a perception issue for the chief to work on. Nobody else but the chief. And he knows that."


