THIRD AMENDMENT TO PERMIT NO. 30130

THIS THIRD AMENDMENT TO PERMIT NO. 30130 is made and entered, in duplicate, as of November 6, 2017, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on May 23, 2006, by and between KEN WILLIAMS, an individual, doing business as CALIFORNIA AQUATICS ("Permittee"), whose address is 1077 Pacific Coast Hwy #190, Seal Beach, California 90740, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City and Permittee (the "Parties") entered into Permit No. 30130 (the "Permit"), pursuant to which City granted Permittee the permission to operate an aquatic equipment rental concession; and

WHEREAS, on September 8, 2010, the Parties entered into a First Amendment to the Permit to extend the term to May 31, 2016; and

WHEREAS, on May 4, 2016, the Parties entered into a Second Amendment to the Permit to extend the term to May 31, 2018; and

WHEREAS, the Parties wish to exercise their last option to extend the term of the Permit;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

1. Section 2 of the Permit is hereby amended in its entirety to read as follows:

"2. TERM. The term of this Permit shall commence on June 1, 2006, and shall terminate on May 31, 2021, unless revoked prior to said termination as provided herein. Upon termination of this Permit (whether by lapse of time or otherwise), Permittee shall quit and surrender possession of the premises and remove its personal property therefrom."

2. Except as expressly modified herein, all of the terms and conditions contained in Permit No. 30130 are ratified and confirmed and shall remain in full force and
