Dear Ms. Takii,

am writing today to inform you of a change we are requesting in your bill rates to address new laws regarding the Sick Leave Pay.

As required by the State of California, Assembly Bill 1522 Paid Sick Days, effective July 1, 2015 an employee shall accrue Paid Sick Days at the rate of not less than one hour per every 30 hours worked, beginning at the commencement of employment, for a total of 3 days, as signed into law by Governor Jerry Brown. As such, GSS has received an increase in operating cost in the form of a tax on the employee wage as coverage for AB1522. This has added an additional \$0.25 per hour.
