4 CITY OF LONG BEACH APPROVING THE APPLICATION
5 FOR GRANT FUNDS FOR THE CALIFORNIA CLEAN
6 WATER, CLEAN AIR, SAFE NEIGHBORHOODS, AND
7 COASTAL PROTECTION BOND ACT OF 2002, THE
8 WATER, SECURITY, CLEAN DRINKING WATER, COASTAL
9 AND BEACH PROTECTION ACT OF 2002, AND THE SAFE
10 DRINKING WATER, WATER QUALITY AND SUPPLY,
11 FLOOD CONTROL, RIVER AND COASTAL PROTECTION
12 BOND ACT OF 2006 (PROPOSITION 84) FOR THE WEST
13 SAN GABRIEL RIVER WALK PROJECT.

15 WHEREAS, the people of the State of California have enacted the
16 California Clean Water, Clean Air, Safe Neighborhood Parks, and Coastal Protection
17 Bond Act of 2002 (Proposition 40), and the Water, Security, Clean Drinking Water,
18 Coastal and Beach Protection Act of 2002 (Proposition 50), and the Safe Drinking
19 Water, Water Quality and Supply, Flood Control, River and Coastal Protection Bond Act
20 of 2006 (Proposition 84) which provides funds for the San Gabriel and Lower Los
21 Angeles Rivers and Mountains Conservancy (RMC) Grant Program ; and

22 WHEREAS, The RMC has been delegated the responsibility for the
23 administration of the grant program in its jurisdiction, setting up necessary procedures;
24 and

25 WHEREAS, said procedures established by RMC require the Applicant's
26 Governing Body to certify by resolution the approval of the Application before
27 submission of said Application to the State; and

1 WHEREAS, the Applicant will enter into a Contract with the State of
2 California for the Project;

3 NOW, THEREFORE, BE IT RESOLVED that the City Council of the City
4 of Long Beach hereby:

5 Section 1. Approves the filing of an Application for local assistance
6 funds from the RMC Grant Program for the West San Gabriel River Walk Project under
7 the California Clean Water, Clean Air, Safe Neighborhood Parks, and Coastal
8 Protection Bond Act of 2002 (Proposition 40), the Water, Security, Clean Drinking
9 Water, Coastal and Beach Protection Act of 2002 (Proposition 50), or the Safe Drinking
10 Water, Water Quality and Supply, Flood Control, River and Coastal Protection Bond Act
11 of 2006 (Proposition 84); and

12 Section 2. Certifies that the West San Gabriel River Walk Project is
13 consistent with local or regional land use plans or Programs (or if it is not, that the
14 Project is still approved); and

15 Section 3. Certifies that the Project is consistent with Common Ground
16 and Phase II Final Report; and

17 Section 4. Certified that the Applicant has or will have sufficient funds to
18 operate and maintain the Project; and

19 Section 5. Certifies that the Applicant has reviewed and understands the
20 General Requirements and General Policies in the RMC Grant Program Guidelines ; and

21 Section 6. Appoints the City Manager as agent to conduct all
22 negotiations, execute, and submit all documents including, but not limited to
23 Applications, agreements, payment requests and so on, which may be necessary for
24 the completion of the Project.

25 Section 7. This resolution shall take effect immediately upon its
26 adoption by the City Council, and the City Clerk shall certify the vote adopting this
27 resolution.


