THIS THIRD AMENDMENT TO AGREEMENT NO. 28450 is made and entered, in duplicate, as of February 7, 2007 for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on March 14, 2006, by and between 3D/INTERNATIONAL, INC., a Texas corporation ("Consultant") and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, the parties entered Agreement No. 28450 whereby Consultant agreed to provide as-needed construction management services; and

WHEREAS, the parties desire to extend the term of the Agreement;

NOW, THEREFORE, in consideration of the mutual terms and conditions in Agreement No. 28450 and herein, the parties agree as follows:

1. Section 2 of Agreement No. 28450 is hereby amended in its entirety to read as follows:

"2. TERM. The term of this Agreement shall commence at midnight on August 28, 2001, and shall terminate at 11:59 p.m. on March 31, 2008, unless sooner terminated as provided in this Agreement, or unless the services to be performed hereunder or the Project is completed sooner."

2. Except as expressly amended in this Third Amendment, all terms and conditions in Agreement No. 28450 are ratified and confirmed and shall remain in full force and effect.
