FIRST AMENDMENT TO CONTRACT NO. 30633

THIS FIRST AMENDMENT TO CONTRACT NO. 30633 is made and entered, in duplicate, as of September 8, 2008 for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting held on September 18, 2007, by and between SULLIVAN INTERNATIONAL, INC., a California corporation ("Organization"), with offices located at 110 Pine Avenue, Suite 700, Long Beach, California 90802, and the CITY OF LONG BEACH, a municipal corporation (the "City").

WHEREAS, the City has received a grant from the U.S. Department of Justice ("DOJ") for a program that aims to prevent, control and reduce violent crime, drug abuse and gang activity to residents of the City in Police Beats 4 and 5 (the "Weed and Seed Program"); and

WHEREAS, the funds awarded for the Weed and Seed Program were not expended within the current grant period; and

WHEREAS, the parties entered Contract No. 30633 whereby Organization agreed to provide Weed and Seed Services to residents of the City in Police Beats 4 and 5; and

WHEREAS, the parties desire to extend the term of the Contract to allow for the full execution of the grant and allocated funds;

NOW, THEREFORE, in consideration of the mutual terms and conditions herein contained, the parties agree as follows:

1. Section 3 of Contract No. 30633 is amended in its entirety to read as follows:

"Section 3. The original term of this Contract shall commence at midnight on October 1, 2007, and shall terminate at 11:59 p.m. on September 30, 2008, and the first extended term shall commence at midnight on October 1, 2008, and, unless sooner

terminated as provided herein shall terminate at 11:59 p.m. on September 30, 2009."

 Except as expressly modified herein, all of the terms and conditions contained in Contract No. 30633 are ratified and confirmed and shall remain in full force and effect.
