2 FIRST AMENDMENT TO CONTRACT NO. 30633

4 THIS FIRST AMENDMENT TO CONTRACT NO. 30633 is made and
5 entered, in duplicate, as of September 8, 2008 for reference purposes only, pursuant to a
6 minute order adopted by the City Council of the City of Long Beach at its meeting held on
7 September 18, 2007, by and between SULLIVAN INTERNATIONAL, INC., a California
8 corporation ("Organization"), with offices located at 110 Pine Avenue, Suite 700, Long
9 Beach, California 90802, and the CITY OF LONG BEACH, a municipal corporation (the
10 "City").

11 WHEREAS, the City has received a grant from the U.S. Department of
12 Justice ("DOJ") for a program that aims to prevent, control and reduce violent crime, drug
13 abuse and gang activity to residents of the City in Police Beats 4 and 5 (the "Weed and
14 Seed Program"); and

15 WHEREAS, the funds awarded for the Weed and Seed Program were not
16 expended within the current grant period; and

17 WHEREAS, the parties entered Contract No. 30633 whereby Organization
18 agreed to provide Weed and Seed Services to residents of the City in Police Beats 4 and
19 5; and

20 WHEREAS, the parties desire to extend the term of the Contract to allow for
21 the full execution of the grant and allocated funds;

22 NOW, THEREFORE, in consideration of the mutual terms and conditions
23 herein contained, the parties agree as follows:

24 1. Section 3 of Contract No. 30633 is amended in its entirety to read as
25 follows:

26 "Section 3. The original term of this Contract shall commence at midnight
27 on October 1, 2007, and shall terminate at 11:59 p.m. on September 30, 2008, and the
28 first extended term shall commence at midnight on October 1, 2008, and, unless sooner

2 2. Except as expressly modified herein, all of the terms and conditions
3 contained in Contract No. 30633 are ratified and confirmed and shall remain in full force
4 and effect.
