## FIRST AMENDMENT TO AGREEMENT NO. 31251

## 31251

THIS FIRST AMENDMENT TO AGREEMENT NO. 31251 is made and entered, in duplicate, as of April 26, 2012, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on July 21, 2009, by and between GEODETICS, INC., a California corporation, with a place of business at 2649 Ariane Drive, San Diego, California 92117 ("Consultant"), and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, the City requires specialized services requiring unique skills and software to be performed and used in connection with its ongoing subsidence monitoring and mapping ("Project"); and

WHEREAS, the parties entered Agreement No. 31251 whereby Consultant agreed to provide such services and software; and

WHEREAS, the parties desire to extend the term;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions in Agreement No. 31251 and in this First Amendment, the parties agree as follows:

- Section 2 of Agreement No. 31251 is hereby amended to read as 1. follows
- "2. The initial term of this Agreement shall commence at TERM. midnight on August 1, 2009 and shall terminate at 11:59 p.m. on July 31, 2012. The first extended term of this Agreement shall commence at midnight on August 1, 2012 and shall terminate at 11:59 p.m. on July 31, 2013, unless terminated earlier, as provided in this Agreement. City shall have the option to extend the term of this Agreement for an additional period of one (1) year."
- 2. For the first extended term, City shall pay Consultant in an amount not to exceed Twenty-Nine Thousand Seven Hundred Dollars (\$29,700).
  - 3. Except as expressly amended in this First Amendment, all terms and
