FIRST AMENDMENT TO AGREEMENT NO. 33731

THIS FIRST AMENDMENT TO AGREEMENT NO. 33731 is made and entered, in duplicate, as of February 7, 2020 for reference purposes only, pursuant to Resolution No. RES-14-0106 adopted by the City Council of the City of Long Beach at its meeting on December 2, 2014, by and between I.P.S. GROUP, INC., a Pennsylvania corporation ("Contractor"), with a place of business located at 7737 Kenamar Court, San Diego, California 92121, and the CITY OF LONG BEACH ("City"), a municipal corporation.

WHEREAS, the City of Sacramento has a Contract for the purchase and installation of single-space "smart" parking meters and related equipment ("Sacramento Contract"); and

WHEREAS, pursuant to Resolution No. RES-14-0106, City and Contractor (the "Parties") entered into Agreement No. 33731, to purchase and install electronic parking meters by virtue of the Sacramento Contract; and

WHEREAS, the Parties desire to extend the term one (1) additional one-year period;

NOW, THEREFORE, in consideration of the terms and conditions contained herein, the Parties agree as follows:

1. The term of Agreement No. 33731 shall be extended commencing at 12:01 a.m. on February 4, 2020, and shall terminate at midnight on February 3, 2021, unless sooner terminated as provided in this Agreement, or unless the services to be performed or the Project is completed sooner. The term may be renewed for four (4) additional one-year periods, at the discretion of the City Manager.

2. Except as expressly modified herein, all of the terms and conditions contained in Agreement No. 33731 are ratified and confirmed and shall remain in full force and effect.

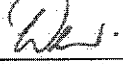
