SECOND AMENDMENT TO AGREEMENT NO. 32793

THIS SECOND AMENDMENT TO AGREEMENT NO. 32793 is made and entered, in duplicate, as of April 4, 2014 for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on August 7, 2012, by and between PADILLA & ASSOCIATES, INC., a California corporation ("Consultant"), with a place of business at 211 E. City Place Drive, Santa Ana, California 92705, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City requires specialized services requiring unique skills to be performed in connection with as-needed professional labor compliancy monitoring services; and

WHEREAS, the parties entered Agreement No. 32793 whereby Consultant agreed to provide such services; and

WHEREAS, the parties desire to extend the term and add \$125,000 for a total not to exceed Contract amount of \$325,000;

NOW, THEREFORE, in consideration of the mutual terms and conditions in the Agreement and in this Second Amendment, the parties agree as follows:

1. Section 1.A. of Agreement No. 32793 is hereby amended to read as follows:

"1. SCOPE OF WORK OR SERVICES.

A. Consultant shall furnish specialized services more particularly described in Exhibit "A", attached to this Agreement and incorporated by this reference, in accordance with the standards of the profession, and City shall pay for these services in the manner described below, not to exceed Three Hundred Twenty-Five Thousand Dollars (\$325,000), at the rates or charges shown in Exhibit "B"."

2. Section 2 of Agreement No. 32793 is hereby amended to read as follows:

"2. <u>TERM</u> . The term of the	nis Agreement shall commence at midnight on
