

1 SECOND AMENDMENT TO AGREEMENT NO. 32793

3 THIS SECOND AMENDMENT TO AGREEMENT NO. 32793 is made and
4 entered, in duplicate, as of April 4, 2014 for reference purposes only, pursuant to a
5 minute order adopted by the City Council of the City of Long Beach at its meeting on
6 August 7, 2012, by and between PADILLA & ASSOCIATES, INC., a California
7 corporation ("Consultant"), with a place of business at 211 E. City Place Drive, Santa
8 Ana, California 92705, and the CITY OF LONG BEACH, a municipal corporation ("City").

9 WHEREAS, City requires specialized services requiring unique skills to be
10 performed in connection with as-needed professional labor compliancy monitoring
11 services; and

12 WHEREAS, the parties entered Agreement No. 32793 whereby Consultant
13 agreed to provide such services; and

14 WHEREAS, the parties desire to extend the term and add \$125,000 for a
15 total not to exceed Contract amount of \$325,000;

16 NOW, THEREFORE, in consideration of the mutual terms and conditions in
17 the Agreement and in this Second Amendment, the parties agree as follows:

18 1. Section 1.A. of Agreement No. 32793 is hereby amended to read as
19 follows:

20 "1. SCOPE OF WORK OR SERVICES.

21 A. Consultant shall furnish specialized services more particularly
22 described in Exhibit "A", attached to this Agreement and incorporated by this
23 reference, in accordance with the standards of the profession, and City shall pay
24 for these services in the manner described below, not to exceed Three Hundred
25 Twenty-Five Thousand Dollars (\$325,000), at the rates or charges shown in
26 Exhibit "B".

27 2. Section 2 of Agreement No. 32793 is hereby amended to read as
28 follows:


1 "2. TERM. The term of this Agreement shall commence at midnight on
2 June 1, 2012, and shall terminate at 11:59 p.m. on May 31, 2015, unless sooner
3 terminated as provided in this Agreement, or unless the services or the Project is
4 completed sooner."

5 3. Except as expressly amended in this Second Amendment, all terms
6 and conditions in Agreement No. 32793 are ratified and confirmed and shall remain in full
7 force and effect.


