THIS FIRST AMENDMENT TO AGREEMENT NO. 28247 is made and entered, in duplicate, as of May 5, 2005 for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on May 3, 2005, by and between BERRYMAN & HENIGAR, a California corporation ("Consultant"), and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, the parties entered Agreement No. 28247 whereby Consultant agreed to provide specialized services requiring unique skills to be performed in connection with As-Needed Architectural & Engineering Design ('Project"); and

WHEREAS, the parties desire to increase the contract amount of said Agreement;

NOW, THEREFORE, in consideration of the mutual terms and conditions in the Agreement and herein, the parties agree as follows:

1. Section 1 of Agreement No. 28247 is hereby amended in its entirety to read as follows:

"1. SCOPE OF WORK OR SERVICES. A. Consultant shall furnish specialized services more particularly set forth in Exhibit "A", attached hereto and incorporated herein by this reference, in accordance with the standards of the profession, and City shall pay for said services in the manner described below, not to exceed \$1,200,000.00."

2. Except as set forth in this First Amendment to Agreement No. 28247, all terms and conditions of said Agreement are ratified and confirmed and shall remain in full force and effect.


