SUBJECT: LBFD Homeless Education And Response Team (HEART)

Honorable Mayor and Councilmembers:

This letter aims to provide you with a testimonial of Downtown Long Beach Alliance's (DLBA) interaction with and support for Long Beach Fire Department's HEART program in its current composition.

The DLBA is a non-profit organization representing more than 1,600 businesses and 4,000 commercial and residential property owners within the two Business Improvement Districts (BIDs) in Downtown Long Beach. During its normal course of service delivery, DLBA's Clean and Safe Team interact with the HEART program to meet the needs of people experiencing homelessness in our Downtown and ultimately benefit its residents, business/property owners, and visitors.

On several occasions, DLBA has contacted Joel Davis (HEART Firefighter/Paramedic) to discuss individuals who appear to need medical services but are resistant to visiting the Emergency Room or Multi-Service Center for medical assistance. In some cases, the person was either transported willingly to the hospital or put on a Lanterman-Petris-Short (LPS) hold due to the severity of their medical situation. Our Clean Team has responded to HEART requests for cleanup at locations where individuals have left trash and other substances after being transported to the hospital.

DLBA's Homeless Outreach Specialist would often coordinate with HEART and other service providers to reach persons living on the street in Downtown. In fact, many persons living on the streets hold HEART in high regard for their willingness to listen to their personal and medical history with a non-judgmental demeanor. Individuals also appreciate the no lights and siren approach, as it is less embarrassing than the traditional fire department response of two fire engines. Without a doubt, it is very beneficial to have trained paramedics that have earned an individual's trust on hand to address an assortment of medical issues in the field or assure the individual that a hospital emergency room is the best course of care.

DLBA appreciates the opportunities to partner with HEART in Downtown and encourages the Mayor, City Council, and staff to maintain the current departmental composition and funding level for this highly effective and beneficial service to persons experiencing homelessness.

My name is Jina Lee Lawler and I am the Chief Operations Officer at The Children's Clinic, "Serving Children & Their Families", DBA TCC Family Health.

The Children's Clinic, "Serving Children and Their Families", DBA TCC Family Health (TCC) is an independent not-for-profit 501(c)(3) licensed 330(c) FQHC community health center with 12 clinical sites, two mobile clinic and an administrative site in the Greater Long Beach area in the state of California. TCC was founded in 1939 when physicians and community leaders came together to provide access to health care for all children, particularly those affected by poverty. Since then, TCC has expanded to serve adults and has undergone tremendous growth, garnering local, state and national respect for the work we do under our guiding mission to provide quality integrated, innovative health care that will contribute to a healthy community, by focusing on those in need and working with patients and the community as partners in their overall well-being.

This week is **National Health Center Week,** and I wanted to take this opportunity, **Health Care for the Homeless Day**, to thank the HEART Team for your continued partnership caring for one of the most vulnerable populations in our community. Providing housing, health care, and basic necessities is a human right, and you all have done tremendous work to ensure those experiencing homelessness have their needs met and also to advocate on their behalf. We honor you and thank you for your commitment and work.

TCC Family Health (TCC), serves as a Patient Centered Medical Home for over 40,000 patients of all ages in more than 140,000 visits per year focusing on moving further upstream with prevention and early intervention services to prevent health and psychosocial issues from becoming chronic health conditions that place individuals at risk for homelessness. TCC also works to address issues and connect individuals and families experiencing homelessness or at risk of homelessness to community resources to help them stabilize their lives and link them to needed resources. TCC is honored to serve almost 1,800 patients experiencing homelessness in over 5,000 visits at the Multi Service Center for Homeless

(MSC), at the Long Beach Rescue Mission, and at our other sites.

While we have not directly worked with the HEART team, I have heard of their work. During this time, where trust between those in uniform and those in our marginalized communities, the HEART team is a model of how those in uniform are part of our network of caring. I have seen HEART team members at community advocacy events speaking about unhoused residents in Long Beach. They work tirelessness to link these individuals to services. Often they are the first point of contact when a unhoused individual is in crisis.

Again, thank you for providing care for those who often are the most marginalized. I look forward to our continued partnerships in the future.

I am writing today in support of the Homeless Education and Response Team (HEART) and the plan for this team in the Long Beach 2021 Proposed budget.

"Redesign and restructure the HEART team model with a greater public health focus and utilize Nurse positions in the Health Department instead of Firefighters" is what the proposed budget states.

While I agree with more collaboration and having more clinicians available to assist with HEARTS mission...this plan is not fully thought out. Not only for the reason that the HEART team should remain under the Homeless Services "umbrella" but the outreach training that will need to occur for our Nurses and Social workers that do not serve on the front lines of outreach. As of now, the Health Department Outreach teams require QOL, LBPD Quality of Life (and MET) teams to go with them on outreach. They do not approach homeless people themselves and require the QOL officer to ask the person experiencing homelessness if they want services. Then, if they do, they bring them over to the outreach worker. (Case workers at MHA still go out by themselves.. Not City Outreach.)

For the collaboration piece, prior to losing our Homeless Services Director a few months back, our HEART and QOL would work together in teams with our city's outreach (many times) Churches and Non Profits that help those experiencing homelessness. (currently, they still do work in teams but since the loss of the Homeless Services Outreach director, the regular meetings have stopped)

As, a board member of Beacon for Him, I can't count how many times I was able to contact both of these teams to help asses and outreach those that needed services. On many occasions I have called the HEART/QOL teams directly to sit in the Beacon building with me when someone was sick, needed a bus ticket to get home, transport to the MSC, help with paperwork, or just talk to someone that needed another perspective and many other occasions when I needed help advocating for a person in need.

In regards to HEART, The call volume the Fire Department gets related to homelessness is highest in the Downtown area. Having the HEART unit there to intercept those calls, spend the time with the individual, and connect them with the most appropriate and definitive care is a major piece in helping someone from the streets to homeless services. We need our street outreached experienced paramedics to continue to grow where they are at and collaborate (again) with QOL, MET, Non Profits, Churches and add LSW's and Nurses. This collaboration would help bridge many of those gaps between services that we see everyday working with someone experiencing homelessness navigating street to home.

These teams are a great example of what we have in place and where to amplify or redirect funding within our LBFD and LBPD in regards to the motivated reconciliation research/conversation and proposed 2021 budget.

Broc, I have had dealings with the Fire Department's HEART program. I have nothing but great things to says about this nationally recognized team. While working at a soup kitchen here in Long Beach I had many opportunities to see them in action. There are always "regulars" in attendance that would show up for a meal. Many were seniors and or veterans. On several occasions we had to call the fire department to our site for medical assistance with this fragile group. Many of them also became regulars with the LBFD. Often it was because they couldn't get to followup appointments or get their refills of blood pressure medications. It was then Heart would get involved .

One case comes to mind of a very gentle man who was living on the streets. I watched his health go down hill over a few weeks. HEART got involved with his care. The team treated him respect and offered him the dignity he deserved, not something this population is used to receiving. This man was very recalcitrant to even go to the hospital before HEART got involved in his care. They convinced him because of his blood pressure and chronic headache to go to the emergency room. They continued to follow up with him and eventually convinced him to make contact with his family. He did which, led to him returning to his family and getting off the streets.

In my opinion, if HEART hadn't developed this relationship with our friend he would have remained on the streets until his early death. HEART needs to stay fully funded. The work they do is essential to the care of our most vulnerable people .

Thank you for your renewed attention to fireworks this year. I would like to request that funding be allocated in the upcoming budget specifically to combat the use of illegal fireworks in Long Beach. There are a few ideas I have for how funding could be allocated to maximize effectiveness: 1. New funding for administrative enforcement of fireworks violations to make enforcement of fines and/or community service easier by reducing the unreasonably high burden of proof currently placed on the prosecution for fireworks violations. Administrative enforcement of fines, if well enforced, may be a significant source of revenue. 2. Increased funding for the City Prosecutor's Community Service program to ensure that violators who cannot pay fines perform their CS obligation. 3. Increased funding for Vice Investigations for the purpose investigating sales, citing and arresting sellers, and seizing large quantities of fireworks before they are sold. This needs to be a priority starting at the very beginning of the summer, and also in the run up to NYE. 4. Increased funding to LBPD analysts to further analyze data on fireworks violations. 5. Funding for Animal Care Services for overtime for at least one week surrounding the Fourth of July and for a large publicity campaign in run up to the Fourth on how to keep pets safe and why fireworks are dangerous for animals (since they are always overwhelmed with scared lost pets at this time). 6. Funding for a city wide publicity campaign against illegal fireworks, stating not only legal the consequences of use but also the countless reasons they are harmful to humans, animals, and the environment. This would be most effective if the city contracted with a local advertising firm. 7. Additional funding for fingerprint analysis of recovered or discarded fireworks or fireworks packaging, in order to assist in generating evidence to support a charge. Thank you for your consideration on the issue of fireworks. It has plagued this city long enough; please do not let it continue to endanger the livelihood of its residents...

The Long Beach Police Department has acted and murdered Long Beach residents with IMPUNITY for far too long, and that is UNACCEPTABLE.

That you all have allowed this and accepted funds of any amount from the LBPOA is UNACCEPTABLE.

I urge you all to think beyond your own lived experience, whether you are white, Black, you work with Police in your profession, whatever it may be, and instead, think of the residents listed above that are dead as a result of encounters with the LBPD. Those 89 people should be alive right now. Think of them, and think of the residents that have voiced their demands to defund and divest from LBPD, and invest in their communities by funding critical and long underfunded services.

Public safety is NOT militarized violent agitators of the State surveilling, bullying, and murdering Long Beach residents. Public safety is NOT overfunding the budget of the LBPD, while defunding and underfunding health care, housing, libraries, etc. year after year. Public safety does NOT look like an impending mass eviction crisis, a pandemic and not enough testing, and increasing homelessness.

Defund LBPD. Fund the demands enumerated in the People's Budget, demands that are bare necessities Black and Brown people have gone without for far too long - accessible, adequate, and affordable housing for ALL; community health; language access; a robust library system universal legal representation for immigrants; ETC.

Simply cutting the LBPD budget by 12% would cover the entire \$30 million shortfall the City faces the upcoming year.

We, the People, realize that you get our message. That crossing guards were moved from the LBPD umbrella over to Public Works demonstrates that. But by making such minor cuts to the budget and the method of achieving most of those cuts - civilianizing the LBPD - does not meet our demands or speak to the spirit of those demands. We will repeat the message until it takes effect and meaningful action is made. DEFUND LBPD, DIVEST FROM LBPD, REDUCE THE OVERALL POWER AND SIZE OF THE LBPD SIGNIFICANTLY, AND REINVEST THOSE FUNDS IN BLACK AND BROWN COMMUNITIES.

Dear Sirs and Madams:

I am a member of the Long Beach Against Illegal Fireworks Facebook group, a resident and business owner in Long Beach, and have spoken on the topic of the detonation of explosives on our streets, a dangerous public safety issue, at the last City Council meeting and also in person some 12 years ago. The difference between then and now is that the situation is clearly out of control with new explosive devices being developed and the use of M80s and other devices that simulate the sound of mortars, gunshot and car bombs. The residents of Long Beach have raised their voices and want neighborhoods free from fear.

I presented a 4-prong approach to this problem in my quick 90-second talk at City Council; namely:

- 1) Re-route the calls to a hotline, away from the non-emergency PD number which interfaces with the police scanner
- 2) Use the already-in-place Long Beach Alert System to announce the City's **no tolerance** approach to this issue with a newly imposed increase in fines of \$3,000 and jail time (flashing signage could also be utilized in neighborhoods that have the highest level of reporting)
- 3) Develop a bold and meaningful community police task force to address this and make it their sole priority with direct access to the hotline
- 4) Review the years of data analytics that you already have on this issue for investigative purposes

I would like to focus on funds being immediately allotted to items #1 and #2 above because I believe that by launching them, you will quickly be able to gain substantial control of an out-of-control, dangerous situation playing out in our neighborhoods four months out of the year, as follows:

*** Setting up a dedicated hotline for reporting explosives and illegal fireworks ***

Perpetrators are not caught in the act because they monitor the police scanner, have cars that follow them around, and are gone from the scene the minute the radio call goes out over the scanner. Callers are also reluctant to leave their names because of retaliation which, by the way, has been reported in the LB Against Illegal Fireworks Facebook page. I, myself, have been through this, and it's intimidating and scary. You will never get ahead of this serious problem unless and until you establish a separate hotline for reporting purposes. Implementing a hotline with a rededication by the

police department to shut this down in our City, will go far in eliminating a large percentage of this problem and will free people who have been afraid to report to come forward. This hotline could be monitored and up and running immediately at very little cost.

***Use of the Long Beach Alert System to Broadcast a No-Tolerance Messaging Program to Remove Explosives and Illegal Fireworks from our Neighborhoods ***

Messaging is important – Messaging is powerful... and when consistently repeated, creates a new paradigm.

This could be started immediately and by coming through the Alert System, it will be unexpected (carrying some needed shock value) and signals very clear and direct attention on the problem and the City's commitment to resolve it.

In Closing

We have a dangerous, quality of life and public safety issue here disrupting our neighborhoods that has been neglected long enough. As was very succinctly stated in the City's Report on Racial Equity under Equity Goals and strategies:

"The purpose of government is to serve its constituents. Policies passed or not passed, funding invested or not invested directly affects **the quality of life in Long Beach neighborhoods**."

Thank you for your consideration of the above recommendations. The people of Long beach deserve to have your attention and action on this problem.

DIVEST FROM THE POLICE DEPARTMENT

Defund the Long Beach Police Department to end their pattern of targeting low-income communities of color and criminalizing poverty. Policing is not the answer to our schools' and communities' most pressing needs, including jobs, housing, homelessness, health, and immigration. When we divest from police, we redirect resources so that Black, Indigenous, and people of color can live successful lives.

REINVEST IN BLACK LIVES AND COMMUNITIES OF COLOR

Reallocate funds and direct additional resources on an on-going basis to community-led priorities that create health, opportunity, community, and justice:

- -Reimagined community safety without police terror and grounded in restorative justice and Black Empowerment:
- --Invest in Black family unification, community-led crisis response, violence reduction, and prevention strategies that are outside of the police;
- --Provide reparations to Black/African American people from the war-on-drugs era and to victims and their families of racial profiling and police violence;
- --Prioritize families directly impacted by the war on drugs in all social and economic opportunities, especially in the equitable ownership of cultivation and distribution in the cannabis industry.
- --Invest in community-led restoration events to support stronger connections among neighbors.

Citywide Rental Housing Division: Establish a Rental Housing Division within the Development Services Department to communicate with both tenants and landlords, issue legal bulletins and updates, enforce renter protection laws, centralize information and forms, and administer a citywide Right to Counsel program for renters.

Community Health Councils: Establish funding for neighborhood-based Community Health Councils to implement community-led crisis response for mental health, safety, and well-

being emergencies.

Job Training: Prioritize free job training and job opportunities for Black residents, regardless of their background or education level. Revise the City's Project Labor Agreement by requiring an independent jobs coordinator, re-defining who qualifies as a Disadvantaged Worker, and adding penalties for noncompliance, so that Black residents actually benefit from these union jobs subsidized by the City.

Language Access: Dedicate adequate staff to implement the City's Language Access Policy (LAP) in full consistently throughout the City and finally create a culture of language justice. Permanently move interpretation and translation services in house to provide faster and higher quality interpretation and translation. Provide Spanish and Khmer interpretation without advance request at all City Council and Charter Commission meetings. Provide community based organizations who work with Limited English Proficiency (LEP) residents ongoing stipends to conduct outreach about the policy.

Senior and Youth Programming: Increase funding for senior and youth development programs and supportive services through community-based organizations, community centers, public libraries, and parks in historically disinvested neighborhoods. Initiate the implementation of the AARP Liveable Cities Initiative that the City committed to over two years ago and has yet to implement.

Universal Legal Representation for Immigrants: Renew and increase funding to the Long Beach Justice Fund to provide free universal legal representation to immigrant residents facing deportation regardless of their background.

The City's budget is a moral document that reflects our city's values and priorities. Adopting the People's Budget is more than just a shift in the way the City has done business-- it is a pathway to ending anti-Blackness and structural racism in the City, undoing historical disinvestment that has continued for generations, and moving us closer towards a Long Beach that is safe and healthy for all.

As a 54 year old, white, cis, male resident of Long Beach, District 2, for 14 years, I am writing to express my extreme disappointment in the City's proposal to cut a mere 1.7% from LBPD's budget in the next fiscal year.

Why do I bring up my age, race, and gender? Because if I, as an older cis white male am disappointed, I cannot even imagine how disappointed, insulted, and completely ignored any Black or brown person of any age or gender must feel at this complete and utter slap in the face to their communities that this sliver of a budget cut represents.

I attended the majority of the Framework for Reconciliation listening sessions, and this tiny proposed budget cut is what I feared the most from those sessions - that the City would quote-unquote listen, and then do virtually nothing. Disappointment, sadness, anger, disbelief are just some of the feelings that this tiny budget cut inspires in me.

The City and its Councilmembers must take bold, meaningful steps to address and dismantle the historical, systemic racial inequities that have

been present in City structures since the founding of Long Beach, and a 1.7% cut to the budget of the structure most responsible for the vast majority of these inequities is frankly laughable as well as shameful.

Be bold, be proactive, live up to the words you all spoke during the Framework sessions where you stated you recognize that we must acknowledge these inequities and not just acknowledge them, but dismantle them. Cutting the police budget by 1.7% dismantles nothing other than the entire Framework for Reconciliation project.

Move the decimal point to the right, make it 17%, not 1.7%, and while 17% is still not enough and is only a beginning, it at the very least shows that you are at least trying to maintain some integrity in the stated goal of addressing and dismantling historic and systemic racial inequities in Long Beach. 1.7% is unacceptable, 5% is unacceptable, 15% is unacceptable.

We must do better than this. Please do better than this. Re-imagine Long Beach. Re-imagine public safety that is based on meeting the needs of all of your citizens, so that policing becomes unnecessary. Take the first step in that direction by committing to reducing the police budget by much, much more than 1.7% and putting those funds to use in social services,

mental health services, and other support services for Black, brown, and historically marginalized and over-policed communities.

Do the right thing, do what you said you were going to do at the beginning of the Framework for Reconciliation.

DIVEST FROM THE POLICE DEPARTMENT

Defund the Long Beach Police Department to end their pattern of targeting low-income communities of color and criminalizing poverty. Policing is not the answer to our schools' and communities' most pressing needs, including jobs, housing, homelessness, health, and immigration. When we divest from police, we redirect resources so that Black, Indigenous, and people of color can live successful lives.

REINVEST IN BLACK LIVES AND COMMUNITIES OF COLOR

Reallocate funds and direct additional resources on an on-going basis to community-led priorities that create health, opportunity, community, and justice:

- -Reimagined community safety without police terror and grounded in restorative justice and Black Empowerment:
- --Invest in Black family unification, community-led crisis response, violence reduction, and prevention strategies that are outside of the police;
- --Provide reparations to Black/African American people from the war-on-drugs era and to victims and their families of racial profiling and police violence;

Citywide Rental Housing Division: Establish a Rental Housing Division within the Development Services Department to communicate with both tenants and landlords, issue legal bulletins and updates, enforce renter protection laws, centralize information and forms, and administer a citywide Right to Counsel program for renters.

Community Health Councils: Establish funding for neighborhood-based Community Health Councils to implement community-led crisis response for mental health, safety, and well-

being emergencies.

Job Training: Prioritize free job training and job opportunities for Black residents, regardless of their background or education level. Revise the City's Project Labor Agreement by requiring an independent jobs coordinator, re-defining who qualifies as a Disadvantaged Worker, and adding penalties for noncompliance, so that Black residents actually benefit from these union jobs subsidized by the City.

Language Access: Dedicate adequate staff to implement the City's Language Access Policy (LAP) in full consistently throughout the City and finally create a culture of language justice. Permanently move interpretation and translation services in house to provide faster and higher quality interpretation and translation. Provide Spanish and Khmer interpretation without advance request at all City Council and Charter Commission meetings. Provide community based organizations who work with Limited English Proficiency (LEP) residents ongoing stipends to conduct outreach about the policy.

Senior and Youth Programming: Increase funding for senior and youth development programs and supportive services through community-based organizations, community centers, public libraries, and parks in historically disinvested neighborhoods. Initiate the implementation of the AARP Liveable Cities Initiative that the City committed to over two years ago and has yet to implement.

Universal Legal Representation for Immigrants: Renew and increase funding to the Long Beach Justice Fund to provide free universal legal representation to immigrant residents facing deportation regardless of their background.

The City's budget is a moral document that reflects our city's values and priorities. Adopting the People's Budget is more than just a shift in the way the City has done business-- it is a pathway to ending anti-Blackness and structural racism in the City, undoing historical disinvestment that has continued for generations, and moving us closer towards a Long Beach that is safe and healthy for all.

For the past two years, the People's Budget campaign has forced conversations and action for equity and justice in the Long Beach city budget. Because Black, Latinx, Cambodian, Filipino, White, and other members of the community came together, Long Beach started reversing historic patterns of disinvesting in communities of color. From language access funding, to a youth strategic plan, to universal legal representation for immigrants, the people have proven we know how to make our communities safe and healthy.

Today, we are at a critical juncture in our city's history and our nation's history. Amid a global pandemic and uprising, we are all bearing witness once again to systemic oppressions driven by racism, capitalism, and white supremacy. Whether it is police criminalizing and committing direct violence on Black bodies or greedy developers gentrifying our neighborhoods and displacing our neighbors, our communities have had enough. Now is the time for bold change that puts Black lives at the center and reduces harm in every way, prioritizes communities first, invests in real essential services, and reimagines community safety.

As a multicultural and multigenerational alliance, we are asking that you adopt the People's Budget for Fiscal Year 2021. Black Lives Matter, and all our communities cannot wait any longer.

DIVEST FROM THE POLICE DEPARTMENT

Defund the Long Beach Police Department to end their pattern of targeting low-income communities of color and criminalizing poverty. Policing is not the answer to our schools' and communities' most pressing needs, including jobs, housing, homelessness, health, and immigration. When we divest from police, we redirect resources so that Black, Indigenous, and people of color can live successful lives.

REINVEST IN BLACK LIVES AND COMMUNITIES OF COLOR

Reallocate funds and direct additional resources on an on-going basis to community-led priorities that create health, opportunity, community, and justice:

- -Reimagined community safety without police terror and grounded in restorative justice and Black Empowerment:
- --Invest in Black family unification, community-led crisis response, violence reduction, and prevention strategies that are outside of the police;
- --Provide reparations to Black/African American people from the war-on-drugs era and to victims and their families of racial profiling and police violence;
- --Prioritize families directly impacted by the war on drugs in all social and economic opportunities, especially in the equitable ownership of cultivation and distribution in the cannabis industry.
- --Invest in community-led restoration events to support stronger connections among neighbors.

Affordable and Supportive Housing: Establish a dedicated source of funding for supportive housing with wrap-around supportive services for residents experiencing or on the brink of homelessness.

Right to Counsel for All Renters: Establish a Right to Counsel to provide legal resources and representation to renters in need regardless of immigration status, effectively reducing evictions, preventing homelessness, preserving affordable housing, and stabilizing communities.

Citywide Rental Housing Division: Establish a Rental Housing Division within the Development Services Department to communicate with both tenants and landlords, issue legal bulletins and updates, enforce renter protection laws, centralize information and forms, and administer a citywide Right to Counsel program for renters.

Community Health Councils: Establish funding for neighborhood-based Community Health Councils to implement community-led crisis response for mental health, safety, and well-

being emergencies.

Job Training: Prioritize free job training and job opportunities for Black residents, regardless of their background or education level. Revise the City's Project Labor Agreement by requiring an independent jobs coordinator, re-defining who qualifies as a Disadvantaged Worker, and adding penalties for noncompliance, so that Black residents actually benefit from these union jobs subsidized by the City.

Language Access: Dedicate adequate staff to implement the City's Language Access Policy (LAP) in full consistently throughout the City and finally create a culture of language justice. Permanently move interpretation and translation services in house to provide faster and higher quality interpretation and translation. Provide Spanish and Khmer interpretation without advance request at all City Council and Charter Commission meetings. Provide community based organizations who work with Limited English Proficiency (LEP) residents ongoing stipends to conduct outreach about the policy.

Senior and Youth Programming: Increase funding for senior and youth development programs and supportive services through community-based organizations, community centers, public libraries, and parks in historically disinvested neighborhoods. Initiate the implementation of the AARP Liveable Cities Initiative that the City committed to over two years ago and has yet to implement.

Universal Legal Representation for Immigrants: Renew and increase funding to the Long Beach Justice Fund to provide free universal legal representation to immigrant residents facing deportation regardless of their background.

The City's budget is a moral document that reflects our city's values and priorities. Adopting the People's Budget is more than just a shift in the way the City has done business-- it is a pathway to ending anti-Blackness and structural racism in the City, undoing historical disinvestment that has continued for generations, and moving us closer towards a Long Beach that is safe and healthy for all.

Do the right thing, adopt the People's Budget.
