FIRST AMENDMENT TO AGREEMENT NO. 35815

THIS FIRST AMENDMENT TO AGREEMENT NO. 35815 is made and entered, in duplicate, as of February 24, 2021 for reference purposes only, pursuant to Resolution No. RES-20-0168 adopted by the City Council of the City of Long Beach at its meeting on December 15, 2020, by and between GALLS, LLC, a Delaware limited liability company ("Contractor"), with a place of business located at 17600 Fabrica Way, Cerritos, California 90703, and the CITY OF LONG BEACH ("City"), a municipal corporation.

City and Contractor (the "Parties") entered into Agreement No. 35185 whereby Contractor agreed to provide police uniforms and accessories; and

WHEREAS, Contractor has an Agreement with the City of Los Angeles for the purchase of police uniforms and accessories, Contract No. 59457 ("LA Contract"); and

WHEREAS, Resolution No. RES-20-0168 authorizes the City to purchase police uniforms and accessories by virtue of the LA Contract; and

WHEREAS, the Parties desire to clarify and amend the term of the Agreement;

NOW, THEREFORE, in consideration of the mutual terms, covenants and conditions herein contained, the Parties agree as follows:

- 1. Section 1.B. of the Agreement is hereby amended to read as follows.
- "B. Contractor shall sell, furnish and deliver to the City police uniforms and accessories of substantially the same type and kind purchased under the LA Contract, except as modified by Exhibit "B" attached hereto and incorporated by this reference, in an annual amount not to exceed Five Hundred Thousand Dollars (\$500,000), inclusive of taxes and fees, until the current Contract expires on November 30, 2021, with the option to renew for as long as LA Contract No. 59457 is in effect."
 - 2. Section 1.F. is hereby added to the Agreement to read as follows:
 - "F. The term of this Agreement shall commence at midnight on December
