

BIOMEDICAL HIV PREVENTION SERVICES

Amendment Number 1

THIS AMENDMENT is made and entered into this 30th day
of September, 2017,

by and between

COUNTY OF LOS ANGELES
(hereafter "County"),

and

CITY OF LONG BEACH
(hereafter "Contractor").

WHEREAS, on February 1, 2016 the County of Los Angeles and City of Long Beach, entered into Master Agreement Number PH-003082 to provide Biomedical HIV Prevention services for the Department of Public Health; and

WHEREAS, reference is made to Master Agreement Number PH-003082 and any amendments thereto (all referred to as "Master Agreement"), between County and Contractor; and

WHEREAS, on August 2, 2016, the County and Contractor, entered into Master Agreement Work Order (MAWO) Number-003082-W1 to provide Biomedical HIV Prevention Services;

WHEREAS, it is the intent of the parties hereto to amend the MAWO to rollover unused funds in the amount of Twenty Thousand Dollars (\$20,000) from Schedule 5 to Schedule 8 and make certain modifications to the MAWO; and

WHEREAS, County has been awarded funds from the federal Centers for Disease Control and Prevention funds, Catalog of Federal Domestic Assistance Number 93.940; and

WHEREAS, Master Agreement provides that changes in accordance to Paragraph 8.1, Amendments may be made in the form of an Amendment which is formally approved and executed by the parties.

NOW, THEREFORE, the parties agree as follows:

1. This Amendment shall be effective on September 30, 2017.
2. Paragraph 1.0, APPLICABLE DOCUMENTS, is hereby amended to replace Attachment C with Attachment C-Revised, and Attachment C-2 with Attachment C-2-Revised.
3. Paragraph 7.0, MAXIMUM TOTAL COST AND PAYMENT, Subparagraphs

7.3 and 7.4 shall be revised to read as follows:

"7.3 Effective September 30, 2016 through September 29, 2017, the maximum obligation of County for all services provided hereunder shall not exceed Two Hundred Eighty-Two Thousand, Four Hundred Fifty-Four Dollars (\$282,454), as set forth in Attachment C-2-Revised, Schedules 3, 4, and 5-Revised, attached hereto and incorporated herein by reference.

7.4 Effective September 30, 2017 through September 29, 2018, the maximum obligation of County for all services provided hereunder shall not exceed Three Hundred Two Thousand, Four Hundred Fifty-Four Dollars (\$302,454), as set forth in Attachment C-2-Revised, Schedules 6, 7, and 8, attached hereto and incorporated herein by reference."

4. Effective on the date of this Amendment, Attachment C shall be replaced with Attachment C-Revised, and Attachment C-2 shall be replaced by Attachment C-2-Revised and incorporated by reference to the MAWO.

5. Effective on the date of this Amendment, Schedule 5 shall be replaced with Schedule 5-Revised.

6. Effective on the date of this amendment, Schedule 8 shall be attached hereto and incorporated herein by reference.

7. Except for the changes set forth hereinabove, the MAWO shall not be changed in any respect by this Amendment.
