RECOMMENDATION:

Adopt the attached Resolution authorizing the temporary closure of certain streets, alleys and walkways in the City of Long Beach in connection with the conduct of the 2017 Formula Drift Pro Championship. (District 2)

DISCUSSION

The 12th Annual Formula Drift Pro Championship will be held in Long Beach from March 31 through April 1, 2017. This event will attract over 25,000 people to the City. In order to allow for the staging of this event, a Resolution has been prepared that provides for the temporary closure of a portion of Shoreline Drive between Ocean Boulevard and Shoreline Village Drive, and various adjacent streets described in the Resolution. This area will be used as part of the venue for the festival, which will also be held on the Marina Green and at Rainbow Lagoon Park. Additional space is required for the safety of event attendees due to projected attendance figures.

Access to the Shoreline Marina and Shoreline Village will be via Shoreline Village Drive. Directional signage will be provided to clearly direct traffic to these areas. The appropriate City Departments have reviewed the requested closure plans.

Traffic management and signage plans will be shared with the public through various media outlets.

This matter was reviewed by Deputy City Attorney Richard F. Anthony and by Assistant Finance Director Lea Eriksen on November 16, 2016.

TIMING CONSIDERATIONS

City Council action is requested on December 13, 2016, to expedite the execution of the Resolution in time for the event.

FISCAL IMPACT

There is no fiscal or local job impact associated with this recommendation.

3 A RESOLUTION OF THE CITY COUNCIL OF THE
4 CITY OF LONG BEACH TO TEMPORARILY CLOSE AND
5 REMOVE FROM PUBLIC USE CERTAIN STREETS,
6 ALLEYS, AND WALKWAYS IN THE CITY OF LONG BEACH
7 IN CONNECTION WITH THE CONDUCT OF THE 2017
8 FORMULA DRIFT PRO CHAMPIONSHIP

10 The City Council of the City of Long Beach resolves as follows:

11 Section 1. The City Council of the City of Long Beach finds and
12 determines that the temporary closing of the streets, described herein, is necessary for
13 the safety and protection of the participants and spectators in the 2017 Formula Drift Pro
14 Championship to be held from March 31, 2017 through April 1, 2017.

15 Section 2. For the conduct of the 2017 Formula Drift Pro Championship,
16 the following streets, alleys, and walkways are hereby temporarily closed for the periods
17 stated:

18 A. On March 31, 2017 through April 1, 2017 from 7:00 a.m. to
19 7:00 p.m., Seaside Way from Pine Avenue to eastern end of Seaside Way,
20 Linden Avenue from Ocean Boulevard to Seaside Way, Marine Way from
21 Locust Avenue to Collins Way, Atlantic Way from Ocean Boulevard to
22 Seaside Way, Marine Way from Hart Place to eastern end, Linden Avenue,
23 northbound and southbound from Shoreline Drive to Marina Parking lot, and
24 Locust Avenue from Ocean Boulevard to Seaside Way.

25 B. On March 31, 2017 through April 1, 2017 from 7:00 a.m. to
26 7:00 p.m., Shoreline Drive westbound from Ocean Boulevard and Alamitos
27 intersection to Shoreline Village Drive.

28 C. On March 31, 2017 through April 1, 2017 from 7:00 a.m. to

1 7:00 p.m., Shoreline Drive eastbound from Shoreline Village Drive to Ocean
2 Boulevard and Alamitos intersection.

3 D. On March 31, 2017 through April 1, 2017 from 7:00 a.m. to
4 7:00 p.m., walkway off of Seaside Way from Hart Place to the east end of
5 Seaside Way.

6 Section 3. The temporary closing of the above streets, alleys, and
7 walkways, for the times herein provided is necessary for the safety and protection of the
8 participants and spectators in the 2017 Formula Drift Pro Championship and qualifying
9 events to be held from March 31, 2017 through April 1, 2017, utilizing the streets
10 described herein.

11 Section 4. For the period March 31, 2017 through April 1, 2017 from 7:00
12 a.m. to 7:00 p.m., the streets, alleys and walkways described in Section 2.A. are hereby
13 withdrawn and removed from public use.

14 Section 5. For the period March 31, 2017 through April 1, 2017 from 7:00
15 a.m. to 7:00 p.m., the streets, alleys and walkways described in Section 2.B. are hereby
16 withdrawn and removed from public use.

17 Section 6. For the period March 31, 2017 through April 1, 2017 from 7:00
18 a.m. to 7:00 p.m., the streets, alleys and walkways described in Section 2.C. are hereby
19 withdrawn and removed from public use.

20 Section 7. For the period March 31, 2017 through April 1, 2017 from 7:00
21 a.m. to 7:00 p.m., the streets, alleys and walkways described in Section 2.D. are hereby
22 withdrawn and removed from public use.

23 Section 8. The City Manager, or his designee, is authorized and directed
24 to post notices of the intent to temporarily reduce lanes, close the streets, alleys,
25 walkways described in Sections 2, 3, 4, 5, 6, and 7 above at least twenty-four (24) hours
26 prior to the closure thereof.

27 Section 9. This resolution shall take effect immediately upon its adoption
28 by the City Council, and the City Clerk shall certify the vote adopting this resolution.
