3 A RESOLUTION OF THE CITY COUNCIL OF THE  
4 CITY OF LONG BEACH AUTHORIZING THE CITY  
5 MANAGER TO EXECUTE A CONTRACT AND ANY  
6 AMENDMENTS THERETO WITH LOCHARD  
7 CORPORATION WITHOUT ADVERTISING FOR BIDS FOR  
8 THE MAINTENANCE, UPGRADE AND SUPPORT OF THE  
9 LONG BEACH AIRPORT NOISE AND OPERATIONS  
10 MONITORING SYSTEM (ANOMS) IN AN AMOUNT NOT  
11 TO EXCEED \$660,500

13 WHEREAS, several years ago the City purchased ANOMS from Harris  
14 Miller Miller & Hanson, Inc. ("HMMH") to enforce the City's Noise Compatibility Ordinance  
15 ("Noise Ordinance"); and

16 WHEREAS, Lochard Corporation has succeeded to the interest of HMMH;  
17 and

18 WHEREAS, the ANOMS system needs to be maintained, upgraded and  
19 supported; and

20 WHEREAS, Lochard Corporation is the only company capable of providing  
21 technical support and services needed for maintaining, upgrading and supporting the  
22 ANOMS system; and

23 WHEREAS, as a result, no useful purpose would be served by advertising  
24 for bids and to do so would constitute an idle and useless act and an unnecessary  
25 expenditure of public funds;

26 NOW, THEREFORE, the City Council of the City of Long Beach resolves as  
27 follows:

28 Section 1. The above recitals are true and correct and are incorporated

2 Section 2. The City Manager is hereby authorized to enter a contract and  
3 any amendments thereto with Lochard Corporation for the maintenance, upgrade and  
4 support of the Long Beach ANOMS System is an amount not to exceed \$660,500.

5 Section 3. This resolution shall take effect immediately upon its adoption  
6 by the City Council, and the City Clerk shall certify the vote adopting this resolution.


