ORDINANCE NO.

AN ORDINANCE OF THE CITY COUNCIL OF THE  
CITY OF LONG BEACH AMENDING THE LONG BEACH  
MUNICIPAL CODE BY ADDING DISTRICT AD TO  
SECTION 10.32.110 CREATING A NEW PREFERENTIAL  
PARKING DISTRICT

WHEREAS, residents on the east side of Clark Avenue and adjacent streets, south of Heartwell Park, contacted the City in 2014, expressing concerns about the negative parking situation in their neighborhood caused by construction projects occurring at the Long Beach City College campus; and

WHEREAS, construction workers, as well as college students, were parking in the neighborhood, severely impacting the residents' parking; and

WHEREAS, in order to address these parking impacts, the City implemented a temporary construction preferential parking district on June 1, 2014; and

WHEREAS, the temporary construction parking district specifies the maximum duration for the district as eighteen (18) months, or when the construction that is causing the parking problem ends; and

WHEREAS, the City Traffic Engineer determined that the temporary parking district would be terminated at the end of 2015; and

WHEREAS, before the implementation of the temporary parking district, the traffic engineering staff conducted parking surveys, demonstrating that the parking requirements were satisfied for the district establishment; and

WHEREAS, a bounded area of sixty-eight (68) homes was determined, with ninety-four percent (94%) support, establishing the district that included streets closer to the college campus; and

WHEREAS, in order to determine support for the establishment of a

1 permanent preferential parking district, the block captain conducted a neighborhood  
2 ballot survey of the streets included in the temporary district; and

3 WHEREAS, the survey ballots, which were submitted to the City Traffic  
4 Engineer, indicated a sixty-eight percent (68%) support to formally request the  
5 establishment of a permanent preferential parking district; and

6 WHEREAS, the City Traffic Engineer has reviewed the results of the  
7 parking study and the resident ballot survey and he has determined that conditions meet  
8 minimum municipal code criteria as outlined in LBMC 10.32.020 for the consideration of a  
9 preferential parking district;

10 NOW, THEREFORE, the City Council of the City of Long Beach does  
11 hereby ordain as follows:

12  
13 Section 1. District "AD" is added to Section 10.32.110 of the Long Beach  
14 Municipal Code to read as follows:

15 District AD: East side of Clark Avenue between Conant Street and  
16 the alley immediately north of Hanbury Street, Hanbury Street between Clark  
17 Avenue and Charlemagne Avenue, north side of Harco Street between Clark  
18 Avenue and Greenbrier Road, Greenbrier Road between Ebell Street and  
19 Parkcrest Street, Parkcrest Street between Greenbrier Road and  
20 Charlemagne Avenue.

21  
22 Section 2. The City Clerk shall certify to the passage of this ordinance by  
23 the City Council and cause it to be posted in three (3) conspicuous places in the City of  
24 Long Beach, and it shall take effect on the thirty-first (31st) day after it is approved by the  
25 Mayor.
