WHEREAS, City and Manager (the "Parties") entered into that certain agreement for parking operations and management services, Agreement No. 32983 (the "Agreement"); and

WHEREAS, the Parties entered into a First Amendment to the Agreement to add additional parking lots and facilities to the list of those managed by Manager; and

WHEREAS, the Parties entered into a Second Amendment to the Agreement to extend the term to March 31, 2017; and

WHEREAS, the Parties desire to exercise their second and final option to extend the term for an additional one (1) year period and add \$3,287,884 to the extended term;

NOW, THEREFORE, in consideration of the mutual terms and conditions herein contained, the Parties agree as follows:

- 1. Section 3 of the Agreement is hereby amended to read as follows:
- "3. <u>TERM.</u> The term of this Agreement shall commence at midnight on April 1, 2013, and shall terminate at 11:59 p.m. on March 31, 2018, unless sooner terminated as provided in this Agreement."
- 2. The Agreement amount shall be increased by Three Million Two Hundred Eighty-Seven Thousand Eight Hundred Eighty-Four Dollars (\$3,287,884) for the term ending March 31, 2018.
 - 3. Except as expressly amended in this Amendment, all terms and
