FIRST AMENDMENT TO PERMIT NO. 32647

THIS FIRST AMENDMENT TO PERMIT NO. 32647 is made and entered, in duplicate, as of November 1, 2013, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach ("City"), at its meeting on February 7, 2012, by and between THE CITY OF LONG BEACH and OC FITNESS BOOT CAMP, ("Permittee").

WHEREAS, City granted Permittee permission to operate an outdoor fitness program and Permittee has requested to continue such operation under Permit No. 32647 solely at El Dorado Park West and City is willing to permit this continued operation under the Permit;

NOW THEREFORE, in consideration of the mutual terms and conditions in Permit No. 32647, the parties agree as follows:

1. Section 2 of Permit No. 32647 is hereby deleted and amended in it's entirety as follows:

"2. TERM. The term of this Permit shall commence on November 1, 2011 and shall end on October 31, 2014. The Director shall have the option in his sole discretion to extend the term of this Permit for two (2), additional one (1) year periods, provided Permittee submits a written request no later than sixty (60) days prior to the expiration of the Permit year."

2. Except as expressly stated herein, all of the terms, covenants, and conditions of Permit No. 32647 are ratified and confirmed and shall remain in full force and effect.
