1 FIRST AMENDMENT TO LICENSE AGREEMENT NO. 33069

3 THIS FIRST AMENDMENT TO LICENSE AGREEMENT NO. 33069 is  
4 made and entered, in duplicate as of January 1, 2014 for reference purposes only,  
5 pursuant to a minute order adopted by the City Council of the City of Long Beach at its  
6 meeting held on March 5, 2013, by and between CONTE PRODUCTIONS, a California  
7 corporation ("Licensee"), and the CITY OF LONG BEACH, a municipal corporation  
8 ("City").

9 WHEREAS, the parties entered Agreement No. 33069 and City granted  
10 Licensee a non-exclusive revocable license to use the Marina Parking Area for the sole  
11 purpose of conducting an arts and crafts market for the sale of arts and crafts items, and

12 WHEREAS, the parties desire to exercise the first option to extend the term  
13 of this Agreement for an additional one (1) year term:

14 NOW, THEREFORE, in consideration of the mutual terms and conditions in  
15 Agreement No. 33069 and herein, the parties agree as follows:

16 1. Section 3 of Agreement No. 33069 is amended in its entirety to read  
17 as follows:

18 "3. Term, Termination and Extension. The term of this First Amendment to  
19 Agreement No. 33069 shall commence on February 1, 2014, and shall terminate on  
20 January 31, 2015, unless sooner terminated as provided in this Agreement, or unless the  
21 services to be performed hereunder or the Project is completed sooner. The term may  
22 be extended for up to three (3) separate, consecutive periods of one (1) year each at the  
23 sole discretion of the City Manager and subject to approval by the Coastal Commission.  
24 Either party may terminate this License by giving at least thirty (30) days prior notice to  
25 the other party as described below."

26 2. Except as expressly amended herein, all terms and conditions in  
27 Agreement No. 33069 are ratified and confirmed and shall remain in full force and effect.
