1 SECOND AMENDMENT TO AGREEMENT NO. 34132

3 THIS SECOND AMENDMENT TO AGREEMENT NO. 34132 is made and
4 entered, in duplicate, as of November 23, 2016, for reference purposes only, pursuant to
5 a minute order adopted by the City Council of the City of Long Beach at its meeting on
6 October 20, 2015, by and between JOVENVILLE, LLC DBA WE THE CREATIVE, a
7 California limited liability company ("Consultant"), with a place of business at 2810 Villa
8 Way, Newport Beach, California 92663, and the CITY OF LONG BEACH, a municipal
9 corporation ("City").

10 WHEREAS, City requires specialized services requiring unique skills to be
11 performed in connection with as-needed graphic design and creative services; and

12 WHEREAS, City and Consultant entered into Agreement No. 34132 (the
13 "Agreement") whereby Consultant agreed to provide these services; and

14 WHEREAS, City and Consultant entered into a First Amendment to the
15 Agreement to increase the amount by \$28,500 for a total not to exceed amount of \$38,500;
16 and

17 WHEREAS, the City and Consultant desire to increase the Agreement
18 amount by \$57,400 for a total not to exceed amount of \$95,900;

19 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
20 conditions herein contained, the parties agree as follows:

21 1. Section 1.A. of Agreement No. 34132 is hereby amended to read as
22 follows:

23 "A. Consultant shall furnish specialized services more particularly
24 described in Exhibit "A", attached to this Agreement and incorporated by this
25 reference, in accordance with the standards of the profession, and City shall pay for
26 these services in the manner described below, not to exceed Ninety-Five Thousand
27 Nine Hundred Dollars (\$95,900), at the rates or charges shown in Exhibit "B"."




