Dear Commissioners,
I oppose this application, and I hope you will deny it.
As I have noted in previous correspondence, Second Street in Belmont Shore is very congested nearly all the time: four lanes of speeding vehicular traffic, almost constant delivery and service vehicles blocking the alleys, lanes of traffic, parking spaces, and transit stops. Pedestrians, bicycles, scooters, and pets make the sidewalks congested, and at times, impassable for disabled people. Adding to this sidewalk congestion are businesses which place signage, equipment, and merchandise on the sidewalk in the public right of way.
Parklets simply do not belong on Second Street. This request is only the first of what will be a dozen or more from other restaurants and bars. They would not add any benefit to the public. Restaurants already have outdoor dining available, space which the city granted long ago for sidewalk dining.
Legends owner Eric Johnson stated in his application that a parklet is "critical to the success of Legends". I have lived in Belmont Shore for forty years. That entire time, Legends has been a thriving and popular business. It has survived a devastating fire which required the complete rebuilding of the business and more recently the Covid pandemic. Legends is thriving today. A parklet is clearly not "critical" to success.
Commissioners, your charter and responsibilities are clear in your name: "Planning Commission". It is your duty to plan and guide the development of the city.
