RECOMMENDATION:

Adopt Plans and Specifications No. R-6807 for the Improvement of Mothers Beach Playground, on Appian Way at Marine Stadium, and authorize the City Manager to award and execute a contract with Mega Way Enterprises, in an estimated amount of \$245,999 plus a 10 percent contingency amount of \$24,600, if necessary, for a total of \$270,599, and any amendments thereto. (District 3)

DISCUSSION

The existing Mothers Beach Playground is a relatively small facility with limited play surfaces and equipment that are in need of refurbishment and expansion. The park facilities are a popular destination for family groups.

The improvements consist of new play surfaces, concrete paths, landscaping, benches and trash receptacles. The new play areas will be a combination of poured-in-place rubber surfacing and sand areas on which the Contractor will install playground equipment furnished by the City. There is also an existing light pole, which will be relocated to the east portion of the play area. The new play area is designed to be fully accessible in accordance with the American Disabilities Act. A vicinity map is attached as Exhibit A.

City Council adoption of the Plans and Specifications and award of the contract to the lowest responsible bidder are being recommended. The project was advertised for bids on July 29, 2009, and bids were opened on August 27, 2009. Information regarding the low bidder, Mega Way Enterprises, is provided on the attached Exhibit B.

This matter was reviewed by Deputy City Attorney Linda Trang on August 31, 2009, and by Budget and Performance Management Bureau Manager David Wodynski on September 1, 2009.

SUSTAINABILITY

Providing improvements to the park play areas not only promotes the health and well being of the family groups and children but also provides a safe, accessible environment for the City residents. The rubber surfacing used in the play area is derived from used tires, eliminating their disposal into landfills.

TIMING CONSIDERATIONS

City Council action on this matter is requested on September 22, 2009, to authorize commencement of this project. Construction is projected to begin in November and should take approximately 70 working days.


FISCAL IMPACT

The contract award is for an estimated amount of \$245,999 plus a 10 percent contingency amount of \$24,600, if necessary, for a total of \$270,599, if necessary. Sufficient funds to cover the contract are budgeted in the Tidelands CIP Fund in the Department of Parks, Recreation, and Marine.



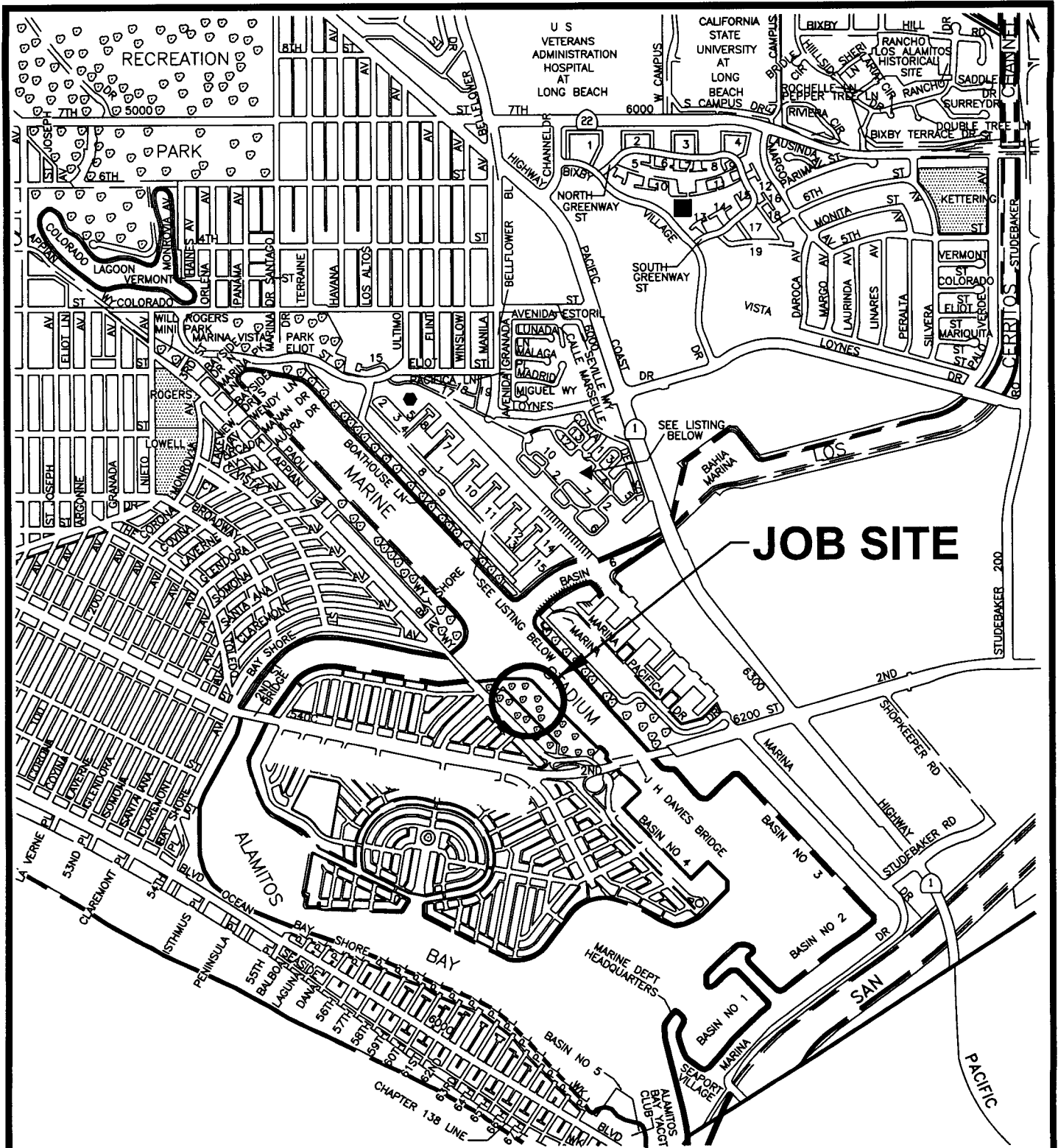

There were twenty-six (26) Plans and Specifications sold. Ten (10) bids were received, one from a local firm, and none from MBEs, WBEs or DBEs.

Linda Trang, Deputy City Attorney, approved the Plans and Specifications on July, 24, 2009.

The above is a construction project, which can be increased up to 25% above the award amount with no further City Council Actions, per the standard Specifications for Public Works Construction ("Green Book") which has been adopted by the City Council.

PROCUREMENT OUTREACH: Advertisements are placed in the Press – Telegram. In a continuing effort to increase participation of Long Beach businesses, MBEs and WBEs, bids for construction projects exceeding \$100,000 are sent, by the Public Works Department, to approximately 20 trade publications and plan rooms catering to the construction industry.
