1 FIRST AMENDMENT TO RIGHT OF ENTRY PERMIT NO. P-00261

3 THIS FIRST AMENDMENT TO PERMIT NO. P-00261 is made and entered
4 as of February 9, 2023 for reference purposes only, pursuant to authorization by the
5 PARKS AND RECREATION COMMISSION of the City of Long Beach ("Commission") at
6 its meeting on January 20, 2022, by and between the PUBLIC CORPORATION FOR THE
7 ARTS FOR THE CITY OF LONG BEACH, DBA ARTS COUNCIL FOR LONG BEACH, a
8 nonprofit corporation ("Permittee"), whose address is 115 Pine Avenue, Suite 350, Long
9 Beach, California 90802 and the CITY OF LONG BEACH, a municipal corporation ("City").

10 WHEREAS, City requires specialized services requiring unique skills to be
11 performed solely for the purpose of working to produce and maintain a mural at Wrigley
12 Heights Dog Park, 3401 Golden Avenue. Long Beach; and

13 WHEREAS, City and Permittee (the "Parties") entered into Permit No. P-
14 00261 (the "Permit") whereby Permittee agreed to provide these services; and

15 WHEREAS, the Parties desire to renew the permit for one (1) three-year
16 period;

17 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
18 conditions herein contained, the Parties agree as follows:

19 1. Section 4 of the Permit is hereby amended to read as follows.

20 "A. Permission to enter shall begin on March 1, 2022, and continue
21 through February 28, 2026, with the option to renew for two (2) additional three-year
22 periods for mural maintenance purposes, at the discretion of the Director. Either party may
23 terminate this Permit with thirty (3) days' written notice."

24 2. Except as expressly modified herein, all of the terms and conditions
25 contained in Right of Entry Permit No. P-00261 are ratified and confirmed and shall remain
26 in full force and effect.
