3 THIS CONTRACT is made and entered, in duplicate, as of August 4, 2011
4 for reference purposes only, pursuant to Resolution No. RES-11-0084, adopted by the
5 City Council of the City of Long Beach at its meeting on August 2, 2011, by and between
6 DOOLEY ENTERPRISES, INC., a California corporation ("Contractor"), with a place of
7 business at 1198 N. Grove Street, Suite A, Anaheim, California 92806, and the CITY OF
8 LONG BEACH ("City"), a municipal corporation.

9 WHEREAS, the City requires standardized Winchester factory-loaded
10 ammunition for their police department; and

11 WHEREAS, Contractor is the sole authorized distributor for Winchester
12 factory-loaded ammunition in Southern California; and

13 WHEREAS, City did by Resolution No. RES-11-0084 determine that the
14 City's need to purchase Winchester factory-loaded ammunition could only be met by
15 Contractor and, by reason of the foregoing, no useful purpose would be served by
16 advertising for bids to purchase such Winchester factory-loaded ammunition and to do so
17 would constitute an idle and useless act and an unnecessary expenditure of public funds;

18 NOW, THEREFORE, in consideration of the mutual terms and conditions
19 contained herein, the parties agree as follows:

20 1. Contractor shall sell, furnish and deliver to City Winchester factory-
21 loaded ammunition as authorized by Resolution No. RES-11-0084 and described in
22 Exhibit "A" attached to this Contract and incorporated by this reference.

23 2. City shall pay Contractor in due course of payments, following
24 receipt of an invoice from Contractor and upon acceptance from City, for Winchester
25 factory-loaded ammunition the prices shown in Exhibit "A", a sum not to exceed Three
26 Hundred Fifty-Four Thousand Dollars (\$354,000), for a period of one (1) year, with the
27 option to renew for two (2) additional one (1) year periods.

28 3. The term of this Contract shall commence on August 15, 2011, and

1 shall terminate at midnight on August 15, 2012 unless sooner terminated as provided
2 herein. The City may terminate this Contract by giving thirty (30) days prior notice of
3 termination to Contractor.

4 4. Neither this Contract nor any of the moneys that may become due
5 Contractor hereunder may be assigned without the prior written consent of City.

6 5. Any notices required hereunder or desired to be given by either party
7 shall be in writing and personally delivered or deposited in the U.S. Postal Service, first
8 class postage prepaid, addressed to Contractor at the address stated herein, and to City
9 at 333 West Ocean Boulevard, Long Beach, California 90802 Attn: City Manager. Notice
10 shall be deemed given on the date personal delivery is made or on the date of deposit in
11 the mail, whichever first occurs.

12 6. City shall have the benefit of any warranty from the manufacturer on
13 the Winchester factory-loaded ammunition, and Contractor warrants that the Winchester
14 factory-loaded ammunition are in good working order and free from defect at the time of
15 delivery.




