2.	Provide all labor, materials and equipment to install a six (6) foot traffic signal davit arm, not depicted on the construction drawing, as directed by the Project Engineer, for the lump sum cost of	.\$	2,800.00
3.	Provide all labor, materials and equipment to install a pedestrian push button on the north west corner of Spring Street and Woodruff Avenue, not depicted on the construction drawings, as directed by the Project Engineer, for the lump sum cost of	.\$	1,500.00
4.	Provide all labor, materials and equipment to remove and replace existing traffic signal pull boxes, as follows: No. 3 pull box located on the north west corner of Del Amo Boulevard and Locust Avenue and No. 5 pull box located on the south east corner of Spring Street and Snowden Avenue,		

In accordance with Section 3-3, Extra Work of the Standard Specifications for Public Works, 2009 Edition, you are authorized to do the following:

as directed by the Project Engineer,

By signing this change order the Contractor acknowledges that it is familiar with California Civil Code Section 1542, which reads: "A general release does not extend to claims which the creditor does not know or suspect to exist in his favor at the time of executing the release, which if known by him must have materially affected his settlement with the debtor;" and Contractor hereby releases the City from any unknown claims and waives its rights under Section 1542.

The prices set forth herein above shall be considered full compensation for all obligations of the contractor associated with this change order, and the City will not be liable for any claim of the contractor for delays or extra compensation resulting from performance of the requirements of this change order.
