HD-7119 FOR AN UNDIVIDED 50% INTEREST (ACTA PARCELS HF-462, HF-462-1, HF-462-2) BETWEEN THE CITY OF LONG BEACH AND THE CITY OF LOS ANGELES, AND MAKING A DETERMINATION RELATING THERETO

WHEREAS, the Board of Harbor Commissioners of the City of Long Beach has adopted Ordinance No. HD-1978 on the 18th day of December, 2006, a complete copy of which is attached hereto as Exhibit "A" and incorporated herein by this reference; and

5 finds and ordains as follows:

6 Section 1. The City Council hereby finds and determines that the Grant
7 Deed No. HD-7119 for an Undivided 50% Interest (ACTA Parcels HF-462, HF-462-1,
8 HF-462-2) between the City of Long Beach and the City of Los Angeles is categorically
9 exempt from the provisions of the California Environmental Quality Act.

10 Sec. 2. The City Council of the City of Long Beach hereby concurs in the
11 findings of, and ratifies, confirms and approves the actions taken by, the Board of
12 Harbor Commissioners of the City of Long Beach in Ordinance No. HD-1978.

13 Sec. 3. The City Clerk shall certify to the passage of this ordinance by the
14 City Council and shall cause the same to be posted in three (3) conspicuous places in
15 the City of Long Beach. This ordinance shall take effect on the 31st day after its
16 approval by the Mayor of the City of Long Beach.

ORDINANCE NO. HD-1978

AN ORDINANCE OF THE BOARD OF HARBOR COMMISSIONERS OF THE CITY OF LONG BEACH AUTHORIZING THE EXECUTIVE DIRECTOR TO EXECUTE A GRANT DEED FOR AN UNDIVIDED 50% INTEREST (ACTA PARCELS HF-462, HF-462-1, HF-462-2) BETWEEN THE CITY OF LONG BEACH, ACTING BY AND THROUGH ITS BOARD OF HARBOR COMMISSIONERS, AND THE CITY OF LOS ANGELES, ACTING BY AND THROUGH ITS BOARD OF HARBOR COMMISSIONERS, REGARDING CERTAIN PREMISES, AND MAKING A DETERMINATION RELATING THERETO

WHEREAS, the Board of Harbor Commissioners of the City of Long Beach ("Board") desires to enter into a grant deed with the City of Los Angeles, acting by and through its Board of Harbor Commissioners, regarding certain premises; and

WHEREAS, guidelines adopted by the Secretary of the California Resources Agency and by the Board, pursuant to Sections 21082-21084 of the California Public Resources Code, provide that certain classes of projects listed therein have been determined not to have a significant effect on the environment and are categorically exempt from the provisions of the California Environmental Quality Act; and

WHEREAS, the Director of Planning and Environmental Services of the Long Beach Harbor Department has determined that, in accordance with said guidelines, said grant deed is categorically exempt.


NOW, THEREFORE, the Board of Harbor Commissioners of the City of Long Beach ordains as follows:

1 Section 1. The Board hereby finds and determines that the Grant Deed
2 for an Undivided 50% Interest (ACTA Parcels HF-462, HF-462-1, HF-462-2), between
3 the City of Long Beach, acting by and through its Board, and the City of Los Angeles,
4 acting by and through its Board of Harbor Commissioners, regarding certain premises,
5 a copy of which is available for inspection in the office of the Executive Secretary of the
6 Board and by this reference made a part hereof, is categorically exempt from the
7 provisions of the California Environmental Quality Act.

8 Sec. 2. The Executive Director of the Harbor Department of the City of
9 Long Beach is hereby authorized to execute the grant deed referred to in Section 1,
10 which is hereby approved.

11 Sec. 3. This ordinance shall be signed by the President or Vice President
12 of the Board and attested to by the Secretary. The Secretary shall certify to the
13 passage of this ordinance by the Board, shall cause the same to be posted in three (3)
14 conspicuous places in the City of Long Beach, and shall cause a certified copy of this
15 ordinance to be filed forthwith with the City Clerk of the City of Long Beach. This
16 ordinance shall take effect on the 31st day after its final passage.


