3 A RESOLUTION OF THE CITY COUNCIL OF THE
4 CITY OF LONG BEACH AUTHORIZING THE CITY
5 MANAGER OR DESIGNEE TO EXECUTE A CONTRACT
6 WITH INNOVATIVE DESIGN AND SHEET METAL
7 PRODUCTS, INC. DBA INNOVATIVE EMERGENCY
8 EQUIPMENT, FOR PROVIDING NEW VEHICLE
9 PREPARATION SERVICES, ON THE SAME TERMS AND
10 CONDITIONS AFFORDED TO THE RIVERSIDE COUNTY
11 SHERIFF'S DEPARTMENT, IN AN AMOUNT NOT TO
12 EXCEED \$95,000 FOR A PERIOD OF ONE YEAR

14 WHEREAS, the Charter of the City of Long Beach, Section 1802, permits the
15 City Manager to enter into a contract on behalf of the City, in writing or otherwise, without
16 advertising for bids, for services, supplies, materials, equipment or labor, with other
17 government agencies, when authorized by resolution; and

18 WHEREAS, the City requires new vehicle preparation services and
19 component preassembly for Police and Fire Department vehicles; and

20 WHEREAS, the Riverside County Sheriff's Department (RCSD) has a
21 contract with Innovative Design and Sheet Metal Products, Inc. dba Innovative Emergency
22 Equipment for new vehicle preparation services, Contract ID # SHARC-05516-006-09/24;
23 and

24 WHEREAS, the City's participation in the RCSD contract will facilitate timely
25 acquisition of new vehicle preparation services, as well as provide considerable cost
26 benefits to the City; and

27 WHEREAS, if the City had to go to formal bid rather than participate in the
28 RCSD contract considerably more funds would be required;

1 NOW, THEREFORE, the City Council of the City of Long Beach resolves as
2 follows:

3 Section 1. The City Manager or designee is hereby authorized to enter an
4 agreement with Innovative Design and Sheet Metal Products, Inc. dba Innovative
5 Emergency Equipment for new vehicle preparation services of the same kind identified in
6 the Riverside County Sheriff's Department Contract in an annual amount not to exceed
7 Ninety-Five Thousand Dollars (\$95,000) for a period of one year.

8 Section 2. This resolution shall take effect immediately upon its adoption
9 by the City Council, and the City Clerk shall certify the vote adopting this resolution.
