

1 THIRD AMENDMENT TO AGREEMENT NO. 32026

3 THIS THIRD AMENDMENT TO AGREEMENT NO. 32026 is made and
4 entered, in duplicate, as of April 14, 2015, for reference purposes only, pursuant to a minute
5 order adopted by the City Council of the City of Long Beach at its meeting on January 4,
6 2011, by and between WILLDAN GROUP, INC., a Delaware corporation ("Consultant"),
7 with a place of business at 13191 Crossroads Pkwy North, #405, City of Industry, California
8 91746, and the CITY OF LONG BEACH, a municipal corporation ("City").

9 WHEREAS, City requires specialized services requiring unique skills to be
10 performed in connection with As-Needed Certified Materials Testing and Inspection, and
11 Construction Management Services; and

12 WHEREAS, the parties entered Agreement No. 32026 whereby Consultant
13 agreed to provide these Services; and

14 WHEREAS, the parties desire to increase the Agreement amount by
15 \$262,536 for a total not to exceed amount of \$3,862,536;

16 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
17 conditions herein contained, the parties agree as follows:

18 1. Section 1.A. of Agreement No. 32026 is hereby amended to read as
19 follows:

20 "1. SCOPE OF WORK OR SERVICES.

21 A. Consultant shall furnish specialized services more particularly
22 described in Exhibit "A", attached to this Agreement and incorporated by this reference, in
23 accordance with the standards of the profession, and City shall pay for these services in
24 the manner described below, not to exceed Three Million Eight Hundred Sixty-Two
25 Thousand Five Hundred Thirty-Six Dollars (\$3,862,536), at the rates or charges shown in
26 Exhibit "B".

27 2. Except as expressly modified herein, all of the terms and conditions
28 contained in Agreement No. 32026 are ratified and confirmed and shall remain in full force

1 and effect.

2 IN WITNESS WHEREOF, the parties have caused this document to be duly
3 executed with all formalities required by law as of the date first stated above.
