
Ms. Hazel Benson has made a claim for injuries allegedly sustained in the course of her employment with the City of Long Beach.

The Economic Development and Finance Committee, on June 15, 2004 approved the submission to the Workers' Compensation Appeals Board of Stipulations with Request for Award/Petition to Reopen based upon a 55 percent permanent disability rating, or the sum of \$52,062.50, with provision for lifetime medical care as may be necessary. The City will receive a credit for a prior Award payment of \$29,750.00.

We, therefore, request authority to submit said Stipulations with Request for Award for approval by the Workers' Compensation Appeals Board, and if so approved, authority to pay **\$22,312.50** (\$52,062.50 less the prior Award of 37%, \$29,750.00), in compliance with the Appeals Board order.


Mr. Craig McCullouch has made a claim for injuries allegedly sustained in the course of his employment with the City of Long Beach.
