## ORDINANCE NO. ORD-05-0028

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF LONG BEACH AMENDING THE LONG BEACH MUNICIPAL CODE BY AMENDING SUBSECTIONS 25B AND 36B OF SECTION 10.12.020, BY ADDING SUBSECTION 71A TO SECTION 10.12.010, AND BY ADDING SUBSECTION 67A TO SECTION 10.12.020, ALL RELATING TO SPEED LIMITS ON CITY STREETS

The City Council of the City of Long Beach ordains as follows:

Section 1. Section 10.12.020 of the Long Beach Municipal Code is amended by amending Subsection 25b to read as follows:

- b. Bellflower Boulevard to Pacific Coast Highway, thirty-five (35) miles per hour;
- Sec. 2. Section 10.12.020 of the Long Beach Municipal Code is amended by amending Subsection 36b to read as follows:
  - b. Artesia Boulevard to the city limits near Fifty-Fourth Street, forty (40) miles per hour;
- Sec. 3. Section 10.12.010 of the Long Beach Municipal Code is amended by adding Subsection 71a to read as follows:
  - a. Ocean Boulevard to The Toledo, twenty-five (25) miles per hour;
- Sec. 4. Section 10.12.020 of the Long Beach Municipal Code is amended by adding Subsection 67a to read as follows:

1	a. Pine Avenue to Linden Avenue, twenty-five (25) miles per hour;

3	Sec.5. The City Clerk shall certify to the passage of this ordinance by the	
4	City Council of the City of Long Beach and cause it to be posted in three conspicuous	
5	places in the City of Long Beach, and it shall take effect on the thirty-first day after it is	
6	approved by the Mayor.
