NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions in Agreement No. 32151 and herein, the parties agree as follows:

- 1. Section 2 of Agreement No. 32151 is hereby amended in its entirety to read as follows:
- "2. <u>TERM.</u> The term of this Agreement shall commence at midnight on May 29, 2011, and shall terminate at 11:59 p.m. on May 28, 2013, unless sooner terminated as provided in this Agreement, or unless the services or the Project is completed sooner. The parties have the option to renew this Agreement for one (1) additional period.
- Except as expressly modified herein, all of the terms and conditions contained in Agreement No. 32151 are ratified and confirmed and shall remain in full force and effect.
