## THIRTEENTH AMENDMENT TO CONTRACT NO. 29298

THIS THIRTEENTH AMENDMENT TO CONTRACT NO. 29298 is made and entered, in duplicate, as of August 16, 2008 for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on July 19, 2005, by and between RAINBOW HARBOR PARTNERS, LLC, a California limited liability company ("V2O") and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, the Long Beach Police Department ("LBPD") provides public law enforcement services within the City of Long Beach; and

WHEREAS, V20 has requested that City provide supplemental law enforcement services in the public area near its night club facility commonly known as "V20" ("the Facility") located in the Pike Entertainment Complex over and above the law enforcement services provided to the public generally; and

WHEREAS, the parties entered Contract No. 29298 and certain amendments thereto (as amended, the "Contract") whereby City agreed to provide supplemental law enforcement services on an occasional basis to V2O as such services are needed; and

WHEREAS, the parties desire to extend the term of the Contract and increase officer wages as indicated on exhibit "A" attached;

NOW, THEREFORE, in consideration of the mutual terms and conditions in the Contract, the parties agree as follows:

- 1. The term of the Contract is hereby extended so that the Contract will remain in effect through November 15, 2008.
- Police Officer wages will be increased as indicated on exhibit "A" attached.
- 3. Except as expressly amended herein, all of the terms and conditions of the Contract are ratified and confirmed and shall remain in full force and effect.
