SECOND AMENDMENT TO AGREEMENT NO. 32379

THIS SECOND AMENDMENT TO AGREEMENT NO. 32379 is made and entered, in duplicate, as of September 12, 2014 for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on October 4, 2011, by and between KOA CORPORATION, a California corporation, with a place of business at 1100 Corporate Center Drive, Suite 201, Monterey Park, California 91754 ("Consultant"), and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, the City requires specialized services requiring unique skills to be performed in connection with As-Needed Transportation Engineering, Transportation Planning, and Related Technical and Professional Services; and

WHEREAS, the parties entered Agreement No. 32379 whereby Consultant agreed to provide these services; and

WHEREAS, the parties desire to extend the term of the Agreement;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the parties agree as follows:

1. Section 2 of Agreement No. 32379 is hereby amended to read as follows:

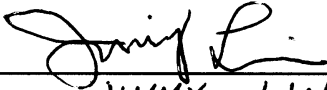
"2. TERM. The term of this Agreement shall commence at midnight on October 5, 2011, and shall terminate at 11:59 p.m. on October 4, 2015, unless sooner terminated as provided in this Agreement, or unless the services or the Project is completed sooner."

2. Except as expressly modified herein, all of the terms and conditions contained in Agreement No. 32379 are ratified and confirmed and shall remain in full force and effect.

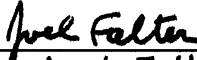
